CALL TO ORDER AND ROLL CALL

00:00:01 The meeting was called to Order by Rep. Barrett, Co-Chairman of the

Environmental Quality Council (EQC).

00:00:49	A list of the subcommittees and proposed members was distributed and discussed. (EXHIBIT 1).

00:03:10	Discussion among EQC members regarding EQC work plan.
00:05:39	Rep. McNutt commented on the proposed time allocation. Rep, McNutt did not believe it was productive for the EQC to argue about .2 of an FTE. Rep. McNutt moved to accept Co-chairs' recommendation on how the work plan should be set up.
00:06:26	Sen. McGee commented on Sen. Wheat's calculations. Rep. Barrett clarified that flexibility exists within the Subcommittees to do whatever the Subcommittee decides.
00:07:48	Sen. Story agreed with the way the Subcommittees were set up and asked about the duties of the full EQC.
00:08:22	Rep. Harris responded to Sen. Story's question and explained that after the review of each Subcommittee report, there would be a substantial

discussion by the full EQC. Rep. Harris believed comprehensive information would be submitted to the EQC for discussion. Sen. Story emphasized the full EQC would need to be fully informed about all Subcommittee activities.

00:09:21 Mr. Everts discussed the possibility of panel presentations being made to the full EQC.

Rep. McNutt commented on the use of subcommittees and suggested utilization of panel presentations would facilitate involvement of the full EQC.

Mr. Mattelin asked about the reason for putting the Superfund Study with the Oversight Subcommittee and suggested it would fit better with the Study Subcommittee, and that water policy should be within the Oversight Subcommittee. Rep. Barrett explained water policy was left with the Study Subcommittee since it would be followup on HB 22. Superfund was put with Agency Oversight since it is a Department of Environmental Quality (DEQ) issue and may result in a white paper. All of the other study issues are with the Department of Natural Resources and Conservation.

00:12:18 The motion to adopt the proposed Work Plan carried unanimously by voice vote.

Rep. Barrett requested volunteers for Subcommittees. The Agency Oversight Subcommittee will consist of Sen. Shockley, Mr. Kok, and Sen. Larson. The Study Subcommittee will consist of Mr. Mattelin, Sen. Lind, and Sen. Story.

Rep. Dickenson asked whether the EQC members would like a copy of the full fire suppression audit or whether they would prefer a copy of the summary of the audit. The members agreed copies of the summary would suffice.

Mr. Everts noted all interim committees have to conclude their business by September 15; therefore, the September 2006 meeting will be September 11-12. Mr. Cebull had a conflict for the July 2006 meeting, so the July meeting will be on the 17th and 18th.
