Judges' Retirement System: Honorable Ed McLean, Judge, 4th Judicial District Revise the Judges' Retirement System by retaining the multiplier at 3 1/3% of the member's current salary for each of the first 15 years of service credit but increasing the current 1.785% of current salary for each year of service credit after 15 years to 3 1/3% a year for each year of service credit after 15 years.

LĆ 150: Clarify sponsor notification for administrative rules -- Sue O'Connell, Research Analyst. LC 150 is a bill drafting request originally made by the Children, Families, Health and Human Services Interim Committee (CFHHS). Conversations among Rep. Diane Sands, Rep. Wilmer, and staff suggest that the SAVA is better suited to consider the proposal than is the CFHHS.

DOA: Janet Kelly, Director, and staff -- "Revise the Mortgage Broker and Loan Originator Licensing Act, (32-9-101, MCA) in response to the national mortgage crisis. The proposal has several components. The proposal will also authorize the department to participate in the National Mortgage Licensing System, contingent on passage of federal legislation This proposal was originally DOA # 6 on the June 30, 2008, SAVA agenda, but was withdrawn from consideration prior to the June 30 meeting.
