Emerging Issue: Medical Marijuana Updated Registry Statistics

July 2010

The following tables update statistics provided in previous briefing papers and are current as of June 30, 2010. The number of patients on the Medical Marijuana Registry increased by 3,380 in June.

The subcommittee on medical marijuana has expressed concern about the number of patients who are 18 to 30 years old and the number who list severe or chronic pain as their debilitating medical condition. The tables below show that the number of patients aged 18 to 30 increased by 1,115 in June; this age group represents nearly 30% of all patients. The number with severe or chronic pain increased by 2,812 in June; patients with this condition represent nearly 68% of total patients.

In June, DPHHS registered an additional 502 caregivers. In the three-month period from March 31 to June 30, the number of caregivers increased by 1,143. The table below shows the number of caregivers, categorized by the number of patients they serve. The largest percentage increases during the three-month period have occurred in the categories of caregivers providing medical marijuana to 10 or more patients; the numbers for those groups have increased from 65% to 76%.
