B. Project Purpose

The purpose of the Labor-Management Advisory Council on Workers' Compensation (hereafter, "Advisory Council") is to provide a structure for an organized discussion of workers' compensation public policy. The primary outcome of the Advisory Council will be recommendations to the Commissioner of the Department of Labor and Industry for proposed legislation for the 2011 Montana Legislature. A secondary outcome will be recommendations to the Commissioner on proposed legislation in the 2009 legislative session and on rule-making activities concerning workers' compensation during the term of the Advisory Council.

C. Project Objective

D. Project Scope

During the initial two years, the Advisory Council researched and discussed four key areas for exploration of policy change, which were identified by the Workers' Compensation Study Project in 2006. These were safety issues, medical issues, return-to-work issues and settlement issues. In addition, the Advisory Council brought forward and dicussed the additional topics of certification of claims examiners, claims closure and course and scope of work. The result was proposed legislation for the 2009 Legislature to fund the WorkSafe MT program, to require a letter of intent for proposed exemptions to workers' compensation, and to set up a voluntary certification program for claims examiners. In addition, the Advisory Council discussed and supported the changes to the nonfacility and facility fee schedules implemented in 2008 with rule-making authority from the 2007 Legislature.

During the next two year-term, the project scope of the Advisory Council will initially be:

Guide and support the workplace safety and transitional employment programs of WorkSafeMT

Promote the passage of the Advisory Council's legislation in the 2009 Legislature

Review for possible endorsement workers' compensation-related legislation proposed by others during the 2009

Legislature

It is anticipated the project scope will be expanded and this charter modified during or after the 2009 Legislature. Project scope decisions will be made by the Advisory Council within the parameters of the agency order. Subsequent modifications to the project scope will require a formal motion and vote by the Advisory Council.
