HJR 8: Childhood Hunger Summary of Suggestions to Date

November 2011

The ideas were presented by panelists or submitted as written comment. The table is intended to help the Children, Families, Health, and Human Services Interim Committee narrow the focus of the study for the remainder of the study period.

- · draft legislation;
