Introduction

House Bill 142, approved by the 2011 Legislature, requires interim committees to review advisory councils and agency reports that have been created by law. Under HB 142, each interim committee is to conduct a review of the councils and reports required of agencies for which they have oversight authority.

As a result, the Children, Families, Health, and Human Services Interim Committee is required to review councils and reports related to the Department of Public Health and Human Services (DPHHS).

In November 2011, the committee decided to review any type of advisory body that is created by law. For DPHHS, these range from formal "advisory councils" to committees, coalitions, and commissions. All told, 18 entities exist in statute to advise DPHHS on items ranging from mental health services to services for senior citizens and for people with disabilities.

This report provides individual information about 13 advisory bodies that are currently active, presented in alphabetical order by name of the group. The information includes:

- the statute creating the advisory group and the purposes it outlines for the group's creation;
- the makeup of the committee and the way in which members are appointed;
- the general activities and duties of the group, including recent activities;
- general budget information; and
- the names and hometowns of current board members.

Five advisory groups either have not met in more than a year or have not yet been appointed because they are newly created. Information about those five groups is summarized on pages 33 and 34.

Options for Committee Consideration

Based on its review of the report and of public comment, the committee could:

- 1. Determine that all the advisory groups perform necessary functions and should remain in statute.
- 2. Determine that some advisory group activities or purposes should be amended to better reflect the current role of an advisory group.
- 3. Determine that some advisory groups should be eliminated.

Options 2 and 3 would require that the committee authorize the drafting of legislation.

Advisory Council on Aging

Statutory Authority: 2-15-232 and 2-15-2206, MCA

Purposes

 Advise the Governor's coordinator of aging and the Department of Public Health and Human Services in planning, coordinating, and operating state programs that affect senior citizens

General Information

Membership:

- 11 members, a majority of whom must be 60 years of age or older
- Governor appoints members
- Members serve 3-year terms
- Meets four times per year, including two conference call meetings

Duties and Activities:

- Assists DPHHS with planning of annual Governor's Conference on Aging
- Reviews the State Plan on Aging
- Follows issues at the local, state, and federal levels that affect senior citizens
- Raises funds for mini-grants that are awarded at the annual Conference on Aging
- · Assists in reviewing mini-grant applications and recommending grant funding

Budget Information

Members are paid for meals, lodging, and travel. Additional costs include the costs for meeting rooms and conference call expenses. The council's expenses in fiscal year 2011 totaled approximately \$7,200.

- Last met in March 2012
- Received reports about aging-related issues in various regions of the state
- Established a subcommittee to review mini-grant requests and prioritize grant awards based on availability of funding

Advisory Council on Food Safety

Statutory Authority: 50-50-103, MCA

Purpose

 Assist DPHHS in the development of administrative rules or review of legislation related to retail food establishments

General Information

Membership:

- Consists of 6 members appointed by the Director
- Composed of equal numbers of representatives of food establishments and representatives of state and local government
- Serve 2-year terms

Duties and Activities:

- Meets as needed to review rule and legislative proposals
- DPHHS is required to present administrative rules and any DPHHS proposed legislation to the Council prior to its proposal or introduction
- If DPHHS learns of proposed legislation that is related to Title 50, ch. 50, MCA, that has not been proposed by DPHHS, DPHHS is required to provide copies of that legislation to the Council for review
- DPHHS is required to inform the Legislature of the Council's comments

Budget Information

Currently, there is no budget. All meetings and communications take place via phone and/or e-mail.

Recent Activities

According to DPHHS, the Council was reestablished in December 2010. Operating procedures were developed to ensure timely review of relevant legislation. Activities conducted included:

- Drafting and distributing operating principles for review (October 2010)
- Conducting a conference call to review and discuss the Council's purpose and to plan future meetings and/or conference calls (December 2010)
- Distributing the draft of HB 191 (revising the licensing and registration provisions for retail food establishments) and conferencing to discuss the bill
- Summarizing and delivering input regarding HB 191 to the House Committee during the hearing

General Information

Membership:

- Three members
- Governor appoints members
- Governor may not appoint a DPHHS employee as a member of the board
- Meets monthly unless no appeals have been filed

Duties and Activities:

- Review and decide denials of public assistance if denial is appealed
- Provide people who have appealed eligibility decisions made by Department of Public Health and Human Services employees with prompt notice and opportunity for a fair hearing

Budget Information

The budget for board member expenses and agency support totaled about \$23,300 in fiscal year 2011. Of that, about \$3,150 was spent on per-diem and travel reimbursements for the board members. The remainder was for staff support of the board's ongoing activities.

Recent Activities

- Last met on March 15, 2012, to review decisions and appeals
- Next meeting scheduled for May 17, 2012

Children's System of Care Planning Committee

Statutory Authority: 52-2-303 and 52-2-304, MCA

Purposes

 Develop an integrated system of services for youth who are seriously emotionally disturbed, are at risk for placement outside of their homes, and need services from more than one state agency

General Information

Membership:

- Eight members required by law, all representing state agencies and programs
- Director of Department of Public Health and Human Services may appoint other members, including members of the public
- Statutory members appointed by state agencies
- DPHHS split the committee into two subcommittees in 2007: the statutorily required committee and a community committee with an emphasis on participation by family members and youth served by the mental health system

Duties and Activities of Statutory Planning Committee:

- Develop policies to eliminate or reduce barriers to creating a system of care
- Promote development of an array of services that allow youth to remain in state
- Encourage development of local interagency teams
- Plan for increasing the capacity to provide high fidelity wraparound services
- Provide training and technical assistance opportunities throughout the state
- Meet monthly

Duties and Activities of Community Planning Committee:

- Collaborate with stakeholders, families, and youth to improve the delivery and quality of mental health services for youth
- Inform stakeholders about the activities of the Children's Mental Health Bureau
- Meet two to three times per year

Budget Information

Members of the Community Planning Committee are reimbursed for travel expenses. In fiscal year 2011, costs for three committee meetings totaled about \$9,600.

Recent Activities

The Community Planning Committee last met on Feb. 2-3, 2012. In the past year, it has reviewed existing mental health services in Montana, identified possible gaps in services, and discussed which services are most effective. In February, it set priorities for its future work, including support of efforts to expand high-fidelity wraparound services and to increase crisis response capacity in communities. The Statutory Planning Committee meets monthly.

Statutory Authority: 2-15-2214 & Title 52, chapter 7, part 1, MCA

Purpose

Created in 1985 to reduce and eliminate the maltreatment of Montana children.

General Information

Membership:

- 7 members (one board member position is currently vacant)
- 2 members must be chosen from state government agencies involved in education and social work relating to children
- Governor appoints members, ensuring geographic distribution of appointees
- Serve 3-year terms, but may be reappointed

Duties and Activities:

- Meets 4 times per year
- Administers the child abuse and neglect prevention program
- Statutorily mandated to keep costs to a minimum by utilizing existing DPHHS office space, personnel, equipment, and supplies (grant administrator is an employee of DPHHS, CFSD)

Budget Information

Revenue/Funding:

- Federal Community-Based Child Abuse Prevention Grant (CBCAP)
- Special revenue from income tax check-off donations, other donations, interest earnings from endowment, and a portion of divorce filing fees

Expenditures:

- Reimburse two members who travel to quarterly meetings at \$350/meeting for both (third traveling member pays her own way as an in-kind donation)
- Meal expenses are approximately \$100 total per meeting
- Meeting space is provided at no additional cost

- Strategic planning meeting held on February 29, 2012
- Board meeting held March 1, 2012
- Local community-based programs and family resource centers RFP posted March 26, 2012
- Implementing Shaken Baby Prevention and the Period of Purple Crying in Montana

safety agencies

General Information

Membership:

- 13 members, with committee makeup specified in statute to include a range of interested parties
- Governor appoints members
- Members serve 3-year terms
- Committee meets four times per year

Duties and Activities:

- Establish policies and procedures for administration of the program
- Analyze and approve a budget for administration of services under the program and monitor program expenditures
- Contract with qualified providers to design and put in place telecommunications relay programs that meets the needs of persons with disabilities
- Conduct outreach activities, as mandated by the Federal Communications
 Commission, to Montanans who are deaf, hard of hearing, or blind, to Montanans
 with speech or mobility disabilities, to families of people with disabilities, and to other
 state agencies in order to help the agencies comply with the Americans with
 Disabilities Act

Budget Information

In fiscal year 2011,committee-related expenses totaled about \$13,675, including about \$5,000 for the \$50 daily honorarium that committee members receive. The expenses also included travel reimbursement for members, as well as the costs of interpreters and captioning services to accommodate the needs of members.

Mental Health Oversight Advisory Council

Statutory Authority: 53-21-702, MCA

Purpose

 Statutorily created in 1999 to provide input to DPHHS in developing and managing a public mental health system

General Information

Membership:

- Appointed by DPHHS
- 27 members (as of January 2012), half of whom are required by statute to be mental health services consumers, former recipients of mental health services, or immediate family members of mental health services recipients
- Other members include advocates for mental health consumers and their families, mental health providers, legislators, the public, and DPHHS representatives
- Appointments must satisfy federal requirements for state oversight entities
- Geographic representation considered when appointing members
- Serve 4-year terms

Duties and Activities:

- Meets two times per year
- Required to provide the Legislative Finance Committee (and other designated interim committees, if any) with summaries of each meeting and recommendations made to DPHHS (DPHHS must provide these same committees with its rationale for not accepting or implementing any Council recommendation)
- Reviews and makes recommendations on the plan for federal mental health funds
- Advocates for adults with mental illness and seriously emotionally disturbed children
- Monitors, reviews, and evaluates at least annually the allocation and adequacy of mental health services within Montana

Budget Information

Federal law requires states to perform mental health planning as a condition of receipt of federal Mental Health Block Grant funds. Montana's annual grant totals about \$1.2 million. Fiscal year 2011 expenditures were as follows:

- Members' travel, lodging, and per diem: \$5,350.62
- Teleconferencing: \$4,861.04
- Meeting space and catering: \$2,344.57
- Staff time (salary & benefits): \$19,536

- Identifying solutions to crisis stabilization services for children
- Developing recommendations for effective youth transitions
- Planning and developing Council priorities for fiscal year 2013

- Coalition meets at least annually

Duties and Activities:

- Review section 1115 Medicaid waiver proposals
- Hear and provide on health care topics in order to promote short- and long-range planning for Montana's health needs, with a special emphasis on low-income residents
- Review and offer advice on other health care initiatives and proposals dealing with state health issues and services

Other Information

- Meets the federal requirement for a group that advise the Department of Public Health and Human Services and Medicaid administrators about health and medical care services
- Federal regulation establishes requirements for membership of federally required advisory group, including physicians, other health care professionals, and consumer groups

Budget Information

DPHHS spent about \$2,135 for two meetings of the coalition in fiscal year 2011.

- Last met on March 14, 2012
- Heard updates on DPHHS Medicaid-related activities, including existing waivers and proposed waivers
- Provided comment on DPHHS activities

Regional Trauma Care Advisory Committees

Statutory Authority: 50-6-411, MCA

Purpose

 Reduce the incidence of trauma injuries in Montana and promote and advance excellence in the care of injured patients

General Information

 Consist of Western, Central, and Eastern RTACs, which are organized along geographic medical referral patterns

Membership:

- Designated trauma facility appoints members
- Statutorily required to appoint one representative to an RTAC for a 4-year term
- Members include representatives from both designated and nondesignated hospitals
- Facilities identify appropriate trauma program staff to participate, including trauma coordinators/registrars, physicians, and EMS responders
- Serve 4-year terms, may be removed for cause, and may be reappointed
- Formal appointments are problematic; members are retained for as long as they remain active in their positions
- Receive no compensation for services or reimbursement for expenses

Duties and Activities:

- Meet four times per year
- Establish standards, policies, procedures, and protocols for regional trauma care system
- Conduct regional quality care improvement and make recommendations to regional trauma care facilities based upon reports provided by DPHHS
- Advise the Trauma Care Committee regarding Montana's trauma care system
- Establish trauma care education and prevention programs and advise health care facilities and providers about trauma care
- Perform other duties required by DPHHS and conduct other activities to ensure quality trauma care

Budget Information

There are not any budgeted costs for conducting RTAC meetings other than staff travel to the meetings. Hospitals cover the costs for their staff to participate. The "hosting" hospital sites (Missoula, Great Falls, and Billings) provide meeting rooms, refreshments, and meals, as well as Telemed for those who are not able to attend in person.

EMS and trauma staff attend each RTAC meeting. However, due to workload and/or

weather, only two to four of the meetings for each RTAC are attended in person. Motor pool and travel expenses for staff are approximately \$35 for Great Falls; \$50 for Missoula, and \$90 for Billings. Annual costs for staff to attend all RTAC meetings are approximately \$350 to \$700, depending on the number of meetings attended.

Recent Activities

- Reviewing clinical care trauma cases, performance improvement, and peers at each meeting
- Continuing education for identified clinical and regional trauma topics
- Identifying regional trauma issues
- Reviewing 2011 air medical activation guidelines
- Reviewing 2012 trauma field decision/team activation criteria
- Reviewing anticoagulation reversal procedures and transfusion procedures
- Reviewing local and regional performance improvement activities
- Reviewing regional trauma registry data and performance improvement indicators

- Collaborate with DPHHS and Local Advisory Councils (LACs) for regional planning and oversight of mental health services within a service area
- Promote consumer and family leadership within the mental health care system in order to advance access to mental health services and individual choice

General Information

 Divided into three regions: Western Service Area Authority (WSAA), Central Service Area Authority (CSAA), and Eastern Service Area Authority (ESAA)

Membership:

- DPHHS approves a leadership committee within each service area, which, in turn, establishes a board and adopts bylaws
- Includes mental health services providers, county commissioners, consumers of mental health services, and family members of consumers of mental health services
- Includes representatives of LACs
- Regional members are not appointed or elected -- membership is open
- Board members are elected by a leadership committee and serve 1-3 years, with reelection possible

Duties and Activities:

- Leadership committees meet one to four times per year
- Boards meet monthly
- Receive proposals and/or recommendations from LACs regarding issues affecting local communities
- Serve in a collaborative and planning role for DPHHS

Budget Information

Each SAA has nonprofit status, serves as an instrumentality of the state, and receives funding from the Addictive and Mental Disorders Division (AMDD) to cover meeting expenses, including travel and per diem. Fiscal year 2011 contract amounts were \$35,000 for ESAA, \$25,000 for CSAA, and \$25,000 for WSAA. AMDD hosts an annual meeting for the combined SAA boards, paid for by the SAAs. AMDD staff attend the SAA meetings, but do not have responsibilities other than to provide DPHHS updates. Typical staffing functions are provided by the SAAs.

- Provides direction to DPHHS regarding trauma care, implementation of a hospital data collection system, and the design and implementation of a statewide quality improvement system for trauma care

- Oversees and provides recommendations to the regional trauma care advisory committees

Budget Information

Some advisory bodies established in statute have not been active in recent years. Those entities, their purposes, and the current status of each are summarized below.

CHILD SUPPORT ENFORCEMENT ADVISORY BOARD

Statutory Authority: 40-5-906, MCA

Purposes

- Advise DPHHS about the policy, direction, control, and management of the child support case registry and payment processing unit
- Advise DPHHS on forms, data processing needs, contract terms, and cooperative agreements related to child support enforcement
- Under the law, DPHHS may enter into contracts to establish, operate, or maintain the
 case registry and payment processing unit and related functions if there is a board to
 act in an advisory capacity

Status

- Board has been disbanded
- DPHHS is unable to identify when the board was disbanded but believes it may have been in 2004
- The Child Support Enforcement Division uses state employees, rather than a contractor, to operate the case registry and payment processing unit.

COMMUNITY HEALTH CENTER ADVISORY GROUP

Statutory Authority: 50-4-810 and 50-4-811, MCA **Purposes**

- Oversee the DPHHS grant process for creating and supporting new nonfederally funded community health centers and expanding services at existing CHCs
- Make recommendations on applications for grant funds

Status

- Advisory group was created in 2007 and was active in 2007 and 2008
- Legislature has not appropriated funds for the grant program since 2007, so group has been inactive since 2009

MONTANA 2-1-1 COMMUNITY COALITION

Statutory Authority: 53-1-703, 53-1-704, 53-1-710, and 53-1-711, MCA **Purposes**

 Assist the Department of Public Health and Human Services in developing a strategic plan for putting in place, operating, and evaluating a 2-1-1 system to provide public information on and referral to local resources related to disaster, emergency, safety, health, or human services topics Provide a report to the Children, Families, Health, and Human Services Interim Committee and the Legislature each biennium

Additional Information

- Created by 2005 Legislature
- No funding provided for advisory coalition
- Governor did not appoint coalition members because of lack of funding; DPHHS established an informational work group that met three times

Status

- Coalition submitted a report to the Legislature on Nov. 1, 2006
- DPHHS has not continued to work on 2-1-1 activities since completion of the report. However, individual 2-1-1 call centers continue to serve various areas of the state.

MEDICAID MANAGED CARE ADVISORY COUNCIL

Statutory Authority: 53-6-710, MCA

Purposes

- Review requests for proposals for Medicaid managed care programs
- Review contracts proposed to be awarded for managed care
- Hold a public hearing in the area affected by a proposed managed care effort and submit a report of its findings related to the public comment process to the Legislature, the Legislative Auditor's Office, and DPHHS

Status

- Council created by Senate Bill 351 in the 2011 Legislature
- DPHHS is considering members for appointment; no managed care proposals are pending

COMMISSION ON PROVIDER RATES AND SERVICES

Statutory Authority: Title 53, Chapter 10, Part 2, MCA **Purposes**

- Monitor the Medicaid reimbursement rates paid to providers of Medicaid services in order to ensure that state funds are spent appropriately, providers are treated fairly, and consumer and taxpayer expectations are met
- Create a protocol for recommending provider reimbursement rates
- Recommend reimbursement levels, rate equity among serve levels, and costeffective methods of regulating and auditing provider services

Status

- Meetings are held at the call of the presiding officer
- The last meeting appears to have been held in September 2010
- DPHHS says it is waiting for the Commission to prioritize its requests for information
