# **Board of Plumbing**

**2-15-1765**, **MCA** - Nine-member board appointed by the governor with the consent of the Senate. Two members must be master plumbers and 2 must be journeyman plumbers. All of these are to be at least 18 years of age and residents of Montana for more than 1 year and licensed at least 5 out of the 8 years immediately preceding their appointment. Three members must be public representatives not engaged in the plumbing business. One member must be a registered professional engineer qualified in mechanical engineering. One member is to be appointed from the Department of Environmental Quality (DEQ) with expertise in regulating drinking water systems.

### Scope of Practice

*Master plumber* - defined in 37-69-101 as a person authorized "to plan, estimate, bid, contract for, and supervise plumbing work and who may do the work of a journeyman plumber".

Journeyman plumber - defined in 37-69-101 as a person authorized "to make installation of all sanitary plumbing and potable water supply piping and appliances connected to the plumbing and piping".

Exclusions to licensing requirements include: owners of a single-family residence doing their own plumbing/potable water supply, connections by mobile home/manufactured housing dealers to existing sanitary/potable water supply facilities upon delivery/set-up; in mines, mills, smelters, refineries, or railroads; in farms or ranches not connected to public water supply and sewage disposal; in cities, towns, water districts, and water user associations regarding their own water and sewer mains; minor work by appliance dealer employees/ agents when installing appliances; or in cases of private water supplies or installation of water meters.

# Other References to Plumbing in Montana Statutes:

- Prevailing wage rates for public contracts in 18-2-413
- For a chapter on plumbing installations under Title 50, chapter 60 regarding building construction standards, 50-60-502 notes that there is no penalty on a person hiring or contracting with an unlicensed person to do work in the field of plumbing. "However, a person who engages in the field of plumbing at a time when the person is not duly licensed is subject to the penalties imposed by this part and Title 37, chapter 69".

# 2011 Bill Affecting Plumbing Profession

• HB 307, introduced by Rep. Tom Burnett, would have prohibited building codes from requiring mandatory sprinkler systems. The bill was vetoed, and the veto sustained.

## Summary of 21 Responses from Survey as of April 4, 2012:

Responses from Board of Plumbers licensees

- Concerns about high licensing fees and the board's response to unlicensed practice. One comment was that the board is mired in procedural process and allows the department to set policy. Another expressed concern about home owners being able to do their own plumbing and not being inspected, which is a concern if they sell the home to someone else.
- Concerns work being performed on state property within cities. One respondent suggested noncompliant plumbing work is being done at Montana State University-Bozeman, which "is costing the state a bundle in labor".
- Concerns about gas piping and hydronic heating not being under the plumbers' license.
