**Subject:** Support self-regulation for dental hygiene

To: Chairman Berry and Members of the Economic Affairs Interim Committee

I have practiced dental hygiene since 1984 when I graduated from the dental hygiene program at Carroll College. I am currently employed at Montana State University-Great Falls, College of Technology, as the clinical coordinator and full time faculty in the dental hygiene program. I have also served in many capacities with my professional organization and I can tell you that if it were not for the continued efforts on behalf of our state and national organization each legislative session, dental hygienists' licensed in the state of Montana would still be practicing according to the way MDA and the Board of Dentistry would have us practice.

We have advanced our scope of practice according to what we have been educated and trained to do always facing road blocks from the very people who serve as our employers and those who serve on the Board of Dentistry. There will never be equal representation for our profession if something is not done to change the current make-up of the board.

Dentists have a history of coming to the legislature and telling everyone who will listen, that dental hygienists' are not educated enough to administer local anesthesia, nitrous oxide, render a treatment plan, offer dental hygiene diagnoses, apply sealants, or make decisions related to dentistry on the board itself. As an educator, and a professional, I am here to tell you that a dental hygiene education is very intense and rigorous. The Commission on Dental Accreditation sets the standards for all dental and dental hygiene programs in the nation. Only the best will be accepted into a program and only those who maintain high grades and meet all standard requirements and competencies will graduate from a program. Dental Hygienists are tested constantly throughout their programs as well as once they graduate. They must take a National Board Examination. They must also take a Regional Board Examination, which mandates they obtain a "real patient" to demonstrate clinical competence, competence with anesthesia, and in some states, competence with restorative procedures. Finally, they must take a jurisprudence exam for licensure and maintain that license with a mandated number of continuing education credits per year.

Most dentists who oppose our professional growth do not even know what our education includes or what our testing standards are. They know their own profession. They should not be granted by virtue of their credentials, the ability to oversee a profession they know little about. Much of their opposition towards us in the legislature is simply based on scare tactics. They are told by their organization that if we increase our scope of practice, then our next step will be wanting to have our own practice and thus leave them without a dental hygienist. Dental hygiene in any practice is a serious percentage of overall production. The fact is, when polled, dental hygienists in this state have made it clear that opening their own practice is not something they are interested in pursuing. We value the dental team and see the relevance of working side by side with a dentist in our practices. The very things which the dentists in this state opposed for dental hygienists have in fact, made their practices more productive. Dentists rely on our education, skills, competence and professionalism on a daily basis and for them to imply that they do not is simply untrue.

In order for dental hygienists in this state to progress and advance in their scope of practice, there must be equal representation on the board or total autonomy from the current board. We are a separate profession and continuing to be regulated by the current board is archaic.

I am a dental hygienist. I would like this committee to either support the dental hygiene committee on the Board of Dentistry having full regulatory power over their own profession or dividing the present Board of Dentistry into two Boards with dental hygienists and denturists separated from the dentists.

The Board of Dentistry is biased to the opinion of the dentists on the board. There are equal numbers of dentists in Montana as there are dental hygienists, yet there are 5 dentists to 2 hygienists. The dental hygienists are essentially voiceless on a Board that regulates their profession.

I am a practicing dental hygienist in the state of Montana and wish to convey my wishes for a Dental Hygiene and Denturist Board separate from the current Board of Dentistry. This would allow dental hygienists to govern themselves (and of course denturists). We have had to convince or if you will "fight" with the Board of Dentistry for years. The opportunity to govern ourselves would be greatly appreciated and put a stop to "turf wars" that always seem to appear when the dentists decide that we are not capable and competent. The people of the state of Montana deserve to have dental hygienists available, particularly in remote areas of this state, to serve in broader capacities than the dentists will currently let us do. These broadened capacities are already in place in the form of the Limited Access Permit. The Limited Access Permit would allow dental hygienists to provide services in schools and other public facilities. Most school access was stopped by the Board of Dentistry and only a handful of schools are currently being served. If you look at the data collected by the state every year, there are needs that could be met by dental hygienists providing services such as sealants. The Montana Dental Hygienists' Association brought legislation that was defeated by dentists lobbying to stop this possibility. These children will remain underserved without dental hygienists being allowed to pursue this endeavor.

This is just one example of the non-professional nature of the current Board of Dentistry.
