RE: Workers' Compensation Insurance Premiums for State Agencies

The purpose of this memorandum is to provide information on the costs of workers' compensation insurance premiums for state agencies in FY 2012 as compared to the budget provided by the legislature. The memorandum also provides information on the impacts of changes contained in HB 334 that also impact state agency budgetary authority as it relates to workers' compensation premiums.

During deliberations on the General Appropriations Act (HB 2), the Senate approved an amendment requested by Senator Ryan Zinke to reduce general fund appropriations of state agencies that had paid some portion of workers compensation costs with general fund in FY 2010 (base year). Reductions totaled \$1,113,150 in FY 2012 general fund appropriation authority for the selected agencies. Figure 1 compares the general fund provided to impacted state agencies including the reduction in the FY 2012 budget and the estimated general fund premium payment for workers' compensation that will need to be paid by the agency in FY 2012.

As shown, overall state agencies had actual premium reductions \$738,440 greater than the reduction of premiums anticipated in the amendment. However, while the majority of agencies can anticipate premium costs funded with general fund below budgeted costs, six agencies have costs above the budgeted amount. For example, the Department of Livestock premium costs funded with general fund will be \$3,431 more than anticipated through the budgeting process. As statute requires state agencies to pay the premiums in full in the year they are assessed regardless of availability of funds, agencies with higher than budgeted premium costs will need to reduce expenditures in other areas to cover the workers' compensation insurance costs. HB 334 was passed by the 2011 Legislature to reduce workers' compensation costs in Montana.

Included in the statute is a requirement that in any year in which the workers' compensation premium due from a state agency is lower than the previous year, the appropriation for that state agency must be reduced by the same amount that the workers' compensation premium was reduced and the difference must be returned to the originating fund instead of being applied to other purposes by the state agency submitting the premium. Figure 2 provides information on the premium costs for state agencies in FY 2011 and FY 2012 to show the impacts of the statute.

As shown, with the exception of the Department of Commerce, under HB 334 all state agencies are required to revert appropriation authority because their FY 2011 premium costs were greater than premium costs in FY 2012. Taken in tandem with the reductions to HB 2 included by the Senate and base budget adjustments, the overall reductions can create budgetary shortfalls for some state agencies. Figure 3 shows the cumulative impacts to funding for workers' compensation insurance premiums between the FY 2012 base adjustments, reductions included in the Senate amendment, and appropriation reductions imposed HB 334.

As shown in Figure 3, the cumulative effect of the various appropriation changes was \$1,363. For the Legislative Branch, the total reductions in appropriation authority require the branch to provide an additional \$829 from other funding sources to meet its obligations.

I requested a legal opinion from the Legislative Services Division to determine if a state agency is entitled to apply a "credit" toward the statutorily required HB 334 reduction by taking into account legislative actions in HB 2 for anticipated savings in workers' compensation. The opinion raises concerns with applying a credit for the legislative amendment to HB 2. I have attached the opinion to this request.

It should be noted that on October 24, 2011 the Office of Budget and Program Planning (OBPP) issued a memorandum to state agencies on the process to follow when accounting for the reductions required by HB 334. The memorandum outlines the calculation of the adjustment state agencies will be required to enter on budget change documents. As part of the calculation, general fund reductions taken on the Senate floor have been used to offset the reductions included in HB 334.
