Administrative Appointments: By Governor. Members serve 3-year, staggered terms.

Statutorily Established - 2-15-3015, MCA. Duties/powers listed in Title 90, chapter 9.

Purposes:

- Establish policies and priorities to enhance future development of agriculture in Montana, including on Indian reservations.
- Make loans or grants under the Growth Through Agriculture Act (in Title 90, chapter 9) to stimulate agriculture development and diversification in rural, urban, and tribal settings;
- Accept grants or other financing or property for use in making grants or loans.
- Adopt rules to establish interest rates, terms of loans or grants, reports required, and deferral or loan forgiveness terms.

Funds available for distribution by Montana Agriculture Development Council

- \$625,000 annually from coal severance tax collections under 15-35-108, MCA, until July 1, 2013, then \$1.25 million annually until June 30, 2019. Statutorily appropriated.
- \$366,678 for FY 2012 and \$366,631 for FY 2013 specifically appropriated through the Coal Tax Shared State Special Revenue Account.
- \$142,292 in FY 2012 and \$187,658 in FY 2013 from the seed capital account under 90-9-301, MCA.
