Gary Mihelish, NAMI-MT, said that the State Hospital is the only place that provides acute care to the mentally ill.

Beth Brenneman, Disability Rights Montana, commented on Mr. Glueckert's presentation and the need for additional community services.

John Lynn, Deputy Director of Western Montana Mental Health Center, Missoula, commented on the crisis programs in Montana.

Janice Reichelt, Phillips County, commented on her son's experience as a forensic patient at the Montana State Prison.

Alicia Pichette, Mental Disabilities Board of Visitors, said that the Board of Visitors has a full-time presence at the State Hospital.
