-- **Comment regarding "just right" scope** - It includes those areas over which we have /should have intervention expertise and excludes those areas that may be a bit 'iffy'. Primarily excludes our bad actors from making claims they can't/shouldn't substantiate. -- Scope of practice is continuing to expand and the board is designed to allow a consensus for regulating these important changes. Opportunities to have discussion about telepractice, requirement for ASHA membership to maintain MT license. Some of the concerns for Audiologists are very different form the clinical practices of speech and language pathologists. -- Now that hearing aid dispensing is included in the audiology scope of practice and separate licensure is no longer required I believe that it is "just right". -- It covers the practices that are expected and traditionally offered by speech-pathologists. I believe audiologists may have other opinions, however, in that there are challenges from medical practitioners, as well as conflicts with hearing aid dealers.

Furthermore, those providing this service need to not only be licensed to practice in MT but need to live in MT.

What laws/regulations have caused the most problems? None = 1

The inclusion of ABA related services for serving children with Autism (33-22-515, MCA) -- Hours of direct supervision of speech pathology/audiology aides. --The number of CEUs required for renewal (40 CEUs every 2 years) is too high, especially for a rural state. This number is higher than even our national professional organization (ASHA) requires (30 CEUs every 3 years). I also would like to see a lower cost for licensure. I realize that the CEU provision is mandated by the legislature...not the Board of SLP/Aud. -- No laws about my profession, but legislation limiting consumers access to the profession through cuts in social services and Medicaid has caused problems. -- No regulation, but keeping up with changes in rules and regulations. -- The language in the law identifying ABA (applied behavior analysis) services for children with Autism. -- Not requiring audiologists to have hearing aid dispensing license created issues with being a Medicaid provider and fitting Medicaid patients with hearing aids without a dispensing license. Regardless, not requiring audiologists to have a dispensing license was a necessary and good change.
