A Bill for an Act entitled: "An Act generally revising laws related to the presiding officer of the board of pardons and parole; requiring the presiding officer to be a full-time salaried position; providing that the presiding officer serves at the pleasure of the governor; amending section 2-15-2302, MCA; providing an effective date; and providing an applicability date."

Be it enacted by the Legislature of the State of Montana:

Section 1. Section 2-15-2302 , MCA, is amended to read:

- "2-15-2302. Board of pardons and parole -- composition -- allocation -- quasi-judicial. (1) There is a board of pardons and parole.
- (2) (a) The board consists of seven members, <u>including the presiding officer</u>. <u>each of whom Each member</u> must have knowledge of American Indian culture and problems gained through training as required by rules adopted by the board. One member must be an enrolled member of a state-recognized or federally recognized Indian tribe located within the boundaries of the state of Montana. The tribal member may not be required to hear and act on all American Indian applications before the board.
 - (b) Board members must have knowledge of serious mental illness

and recovery from serious mental illness gained through annual training as required by rules adopted by the board. One member must be a mental health professional as defined in 53-21-102.

- (c) Board members must possess academic training that has qualified them for professional practice in a field such as criminology, education, medicine, psychiatry, psychology, law, social work, sociology, psychiatric nursing, or guidance and counseling. Related work experience in the areas listed may be substituted for these educational requirements.
- (3) The governor shall attempt to establish geographic balance among board members.
- (4) Board members shall serve staggered 4-year terms. The governor shall appoint three members in January of the first year of the governor's term, two members in January of the second year of the governor's term, and two members in January of the third year of the governor's term. The provisions of 2-15-124(2) do not apply to the board.
- (5) The terms of board members, including the presiding officer, run with the position, and if a vacancy occurs, the governor shall appoint a person to fill the unexpired portion of the term.
- (6) The presiding officer is a full-time salaried position and serves a 4-year term at the pleasure of the governor.
- $\frac{(6)}{(7)}$ The board is allocated to the department for administrative purposes only as prescribed in 2-15-121. However, the board may hire its own personnel, and 2-15-121(2)(d) does not apply.
 - (7)(8) The board is designated as a quasi-judicial board for

purposes of 2-15-124, except that:

- $\underline{\text{(a)}}$ board members must be compensated as provided by legislative appropriation; and
- $\underline{\text{(b)}}$ the terms of board members must be staggered as provided in subsection (4); and
- (c) the presiding officer must be appointed and compensated as provided in subsection (6).
- (8)(9) A favorable vote of at least a majority of the seven members of the board is required to implement any policy, procedure, or administrative rule. A favorable vote of at least a majority of the members of a hearing panel, as defined in 46-23-103, is required to make decisions regarding parole and executive clemency, and the provisions of 2-15-124(8) do not apply."
