RE: Revenue Source Ordering & Assumptions Included in HJ 2

This memo offers two alternatives to the current structure of HJ 2:

1. Matching the order of the general fund and non-general fund revenue estimates to the standard presentation

2. Consistently providing the underlying assumptions of each revenue source if available.

The first change reorders the listed revenue estimates and includes revenue section types where applicable. This would allow for consistency and easier comparison with all current LFD published documents that contain a revenue source listing. Tables of the current and proposed revenue order are included in the body of this memo.

The second change is more substantive. Currently, HJ 2 includes as assumptions intermediate <u>modeled values</u> rather than the underlying assumptions going into the models. An example of this issue is provided by many of the consumption taxes in HJ 2: the current assumptions list estimated quantity sold or consumed, rather than the underlying assumptions of population and personal income that produce those estimates.

The second change proposes to consistently identify the underlying assumptions of each estimate in HJ 2. This would allow for a better understanding of the drivers of each revenue source, and provide more clarity when discussing the forecast of various economic indicators. An example of current and proposed assumptions for oil production tax is included on the last page of this memo.
