Notice of proposed amendment and repeal

SUMMARY OF RULE(S):

The State Lottery Commission (Commission) proposes to amend five rules and repeal five rules. The Commission previously issued MAR Notice No. 2-63-503 concerning the same subject matter. As noted in the February 2014 meeting of the State Administration and Veterans' Affairs Committee, the Commission intended to update certain rule proposals from that notice for further clarification, grammar, consistency, and comportment with the Montana Administrative Procedure Act. Therefore, this notice restates and updates the rule proposals from MAR Notice No. 2-63-503 prior to their adoption.

Specifically, Rule 2.63.407 is updated to clarify that a lottery retailer is entitled to a 5% base commission. Rule 2.63.607 is updated to note that licensees must notify the Commission of any change, move, or removal of lottery terms, equipment, and/or peripherals pursuant to the contract between the licensee and the Commission. Rule 2.63.203 has been revised to delete superfluous definitions, and the Commission proposes to revise the definition of "terminal issued ticket" rather than deleting it. As noted in the previous memo, the Commission has withdrawn the

proposal for the repeal of Rule 2.63.603, and it no longer appears in the updated notice. The Commission also proposes to update the previously proposed language for Rule 2.63.1201 for grammar and consistency.
