# WATER COURT REPORT TO WPIC AND EQC JULY 2014

#### **Status of Interim Decrees**

The Water Court issued 6 Preliminary/Interim decrees in 2013. All of these decrees are in an objection or counter objection period. The table below shows deadlines and objections received as of June 13, 2014.

#### Initial Decrees Remaining to be Issued:

There are 7 initial decrees remaining to be issued. The timing of issuance depends on completion of summary reports by DNRC and subsequent review of those reports by the Court. The DNRC is not scheduled to complete any new summary reports until 2015. No new decrees will be issued until those reports are completed.

The Court anticipates 50 percent of claims will receive DNRC issue remarks or objections. This percentage is based on past averages and represents the number of claims that will be addressed in Court proceedings. Basins without initial decrees are:

#### **Summary Reports**

The Water Court is not currently reviewing any Summary Reports.

#### **Enforcement Actions for 2014**

With the irrigation season underway, the Water Court has begun sending District Courts current enforcement tabulations. As of June 13, 2014, tabulations for 22 projects have been mailed. The Court anticipates a total of 40 total tabulations for the year.

#### Exempt from Filing (SB 355)


SB 355 was passed during the last Legislative session. The resulting law allows individuals to file on exempt claims. The process became operational on October 1, 2013. The Court continues to receive petitions for this process.

#### **Staffing Changes**

Since the last report, the Water Court has added two temporary legal interns. The Water Court lost a Law Clerk and hired a replacement. A vacant Water Master position was also filled and one Deputy Clerk position became vacant.

#### **Progress of Adjudication**

The Water Court continues to work on initiatives to increase productivity, quality, and responsiveness and track progress. The following chart shows the Court's average number of claims closed per month.

#### HB39 Automate Ownership updates (effective July 1, 2008)

-Department staff continue to validate water right geocodes for property transfers that occurred from November 2010 thru January 2012.

-In 2010, 3,821 ownerships were updated involving 9,460 water rights

-In 2011, 6,245 ownerships were updated involving 15,765 water rights.

-In 2012 8,729 ownerships were updated involving 20,496 water rights.

-In 2013 8,208 ownerships were updated involving 19,305 water rights.

-So far this fiscal year 7,618 ownerships have been updated involving 18,360 water Rights

Post Decree assistance primarily involves working with claimants and the Water Court to help resolve issue remarks on water rights. This assistance is generated through the on motion process (85-2-248) and objections by water users resulting in a case. Assistance includes meeting with claimants, conducting field investigations, mapping, and providing recommendations and technical reports pertaining to individual cases. In addition, assistance is requested by the Water Court to help with certified cases before and after the initial decree phase. Unique requests to help the Water Court resolve specific cases such as large basin mapping projects, and other technical requests fall within the general assistance category.

## SB355 Fillings (effective Oct 1, 2013)

The department has received 164 statement of claims to date. 26 of these have the purpose of domestic and 138 have the purpose of stock. Examination is occurring on basins nearing initial decree and basins with notice deadlines.

## Re-examination order on verified and early examined basins

The department has not started working on the 43 basins with approximately 90,000 claims affected by this order. The work involved primarily addresses water distribution issues and is not a full examination of the claims. Work in these basins is anticipated to be complete by July 1<sup>st</sup> of 2021 if additional funding is received to maintain current staffing levels at DNRC and the Water Court.

#### Other additional adjudication work could include:

- Examination and decrees of non-compacted tribal water rights;
- Possible examination of water rights for post-73 abandonment;
