Post Decree assistance primarily involves working with claimants and the Water Court to help resolve issue remarks on water rights. This assistance is generated through the on motion process (85-2-248) and objections by water users resulting in a case. Assistance includes meeting with claimants, conducting field investigations, mapping, and providing recommendations and technical reports pertaining to individual cases. In addition, assistance is requested by the Water Court to help with certified cases before and after the initial decree phase. Unique requests to help the Water Court resolve

specific cases such as large basin mapping projects, and other technical requests fall within the general assistance category.

Ownership updates

- -Department staff continue to validate water right geocodes for property transfers that occurred from November 2010 thru January 2012.
- -In 2010, 3,821 ownerships were updated involving 9,460 water rights
- -In 2011, 6,245 ownerships were updated involving 15,765 water rights.
- -In 2012 8,729 ownerships were updated involving 20,496 water rights.
- -In 2013 8,208 ownerships were updated involving 19,305 water rights.
- -So far this fiscal year 6,269 ownerships have been updated involving 15,219water rights.

SB355 Fillings (effective Oct 1, 2013)

The department has received 134 statement of claims to date. 21 of these have the purpose of domestic and 113 have the purpose of stock. Examination is occurring on basins nearing initial decree and basins with notice deadlines.

Re-examination order on verified and early examined basins

The department has not started working on the 43 basins with approximately 90,000 claims affected by this order. The work involved primarily addresses water distribution issues and is not a full examination of the claims. Work in these basins is anticipated to be complete by July 1st of 2021 if additional funding is received to maintain current staffing levels at DNRC and the Water Court.

Other additional adjudication work could include:

- Examination and decrees of non-compacted tribal water rights;
- Possible re-examination of all water rights for post-73 abandonment.

Status of Interim Decrees

The Water Court issued six Preliminary/Interim Decrees in 2013. These decrees have open objection periods and are currently receiving objections. The table below shows deadlines for objections and the number of objections received as of April 23, 2014.

Initial Decrees remaining to be Issued

There are eight initial decrees remaining to be issued. With present funding and workloads, and assuming continued timely preparation of summary reports by the DNRC, these decrees should be issued before the benchmark deadline of 2020. The Water Court anticipates 50 percent of claims will receive DNRC issue remarks or objections. This percentage is based on historic averages and represents the number of claims forecast for inclusion in court proceedings. Basins without initial decrees are:

40T – St. Mary River

41L - Cut Bank River

41M - Two Medicine River

41P - Marias River

43P – Bighorn River below Greybull River

76HA - Bitterroot River, East side

76L - Flathead River below Flathead Lake

76LJ – Flathead River including Flathead Lake

Compacts

WC 2013-04 – Bowdoin National Wildlife Refuge Compact. On April 2, 2014, Judge McElyea issued the Preliminary Decree for the Bowdoin Compact. The deadline for objections is October 14, 2014.

Summary Reports

The Water Court is reviewing the Summary Report in Basin 40T (St. Mary River). The Court plans to issue the decree for basin 40T in May 2014.

Enforcement Actions for 2014

With the irrigation season about to begin, the Water Court has begun sending water rights tabulations to District Courts. As of April 23, tabulations for nine projects have been mailed.

The Water Court is continuing to work with District Court judges to provide them with complete and enforceable tabulations of enforcement projects. Based on feedback from judges and water commissioners, the Water Court added a remarks section to the tabulations. This section provides the judges and commissioners with information remarks appearing on water right claim abstracts that affect distribution of water.

Exempt from filing (SB 355)

The last legislature passed SB 355. This law allows individuals to file on exempt claims. The process at the Court and DNRC became operational on October 1, 2013. As of April 23, 2014, 134 petitions have been received.

Progress of Adjudication

The Water Court continues to work on initiatives to increase productivity, quality, and responsiveness, and to track our progress in the adjudication. The following chart shows average number of claims closed per month.
