
## National Conference of State Legislatures ~ Convicted Offenders Required to Submit DNA Samples ~

Every state, the District of Columbia and the federal government, collects and tests DNA from individuals convicted of certain crimes. Forty eight states require the collection of DNA for any felony conviction and 42 states require the collection of samples for at least some misdemeanor convictions. New York and Wisconsin have the broadest convicted offender collection policies, taking samples from those convicted of *all* felonies and misdemeanors.

While misdemeanant collection does not stir the same privacy debate as arrestee sampling policies and familial DNA searches, it does expand the number of samples collected and can significantly affect forensic laboratory workloads.



New York, for example, has expanded the crimes for which they collect DNA five times since they began using the technology in 1994, and, except for minor marijuana possession crimes, is currently the only state collecting samples for all misdemeanor convictions. (Wisconsin has enacted a law, but does not begin collecting samples for all misdemeanors until March 1, 2015.) Prior to their last expansion to include all misdemeanors, which took effect August 1, 2012, offenders in the state linked to crimes through DNA averaged three prior non-qualifying convictions before they committed their crime that required DNA sample submission.

New York's Division of Criminal Justice Services <u>tracks statistics and outcomes</u> for DNA sample submissions, including <u>hits that resulted</u> from their different expansions. Additionally, they highlight <u>case specific benefits</u> and provide an <u>interactive map</u> showing the impact of DNA analysis. Also, for each expansion, they provided lawmakers with an analysis of laboratory capacity and how it would be impacted by increased sample submission.

## **Recent Legislation**

In 2013, Wisconsin expanded their collection policies (AB 40) to include all crimes and Iowa (HB 527) added aggravated misdemeanors to the list of crimes for which they collect DNA samples.
