
Montana Teachers' Retirement System





Major Activities Since Last Interim

- Continued progress on the M-Trust project with 11 out of 21 modules now complete
 - Note: M-Trust is the upgraded version of the TRS pension administration software system.
- Implementation of the GASB 68 Standard. TRS received an unmodified opinion from the Legislative Audit Division on the Schedule of Employer and Nonemployer Allocations and Pension Amounts

Key Legislation from the 2015 Legislative Session

• HB 85

TRS Housekeeping bill intended to comply with IRS qualification standards and to clarify aspects of the law with more concise definitions and language. There was no actuarial impact of this legislation.

• SB 124

Requires certain boards including TRS to record public meetings and make the recording available within one business day. The audio minutes for our August 12, 2015 Board meeting are currently available on the TRS website. Beginning with the October 1, 2015 Board meeting, TRS will have video minutes available.

• SB 141

Removed the sunset on 19-20-732, MCA, which allows certain retired members to be employed on a full time basis with no earnings limitation for up to three years. This is available only to retired members who have 30 or more years of creditable service and have received at least two monthly benefits. The employer must certify each year that the position was advertised and they have been unable to fill the position with a qualified individual.

Key Activities for the Current Interim

- Finish the upgrade phase of the M-Trust project and develop a schedule for a subsequent phase to develop and implement system enhancements
- Improve TRS outreach and education materials for members, retirees, employers and interested parties
