RE: Results of the Poll of the Legislature: MAR Notice No. 44-2-207

To Whom it May Concern:

On August 13, 2015, the Commissioner of Political Practices published [MAR Notice No. 44-2-207](#) pertaining to the public hearing on the proposed adoption of 12 new rules, the transfer of 5 rules, the transfer and amendment of 43 rules, and the repeal of 5 rules. The notice is located on pages 1138 through 1192 of the 2015 Montana Administrative Register, Issue Number 15. The proposed rules related to [Senate Bill 89 \(2015\)](#), [Senate Bill 151 \(2015\)](#), [Senate Bill 289 \(2015\)](#), and a reorganization and update of existing rules promulgated by the Commissioner of Political Practices.

**Objection Letters Received**

Section [2-4-403](#), MCA, requires the interim committee that has subject matter jurisdiction over an agency to conduct a poll of the members of the Legislature when 20 or more legislators object to a proposed rule. As of November 13, 2015, the Legislative Services Division had received [23 written objections](#) to 16 of the proposed rules in [MAR Notice No. 44-2-207](#), which fall under the jurisdiction of the State Administration and Veterans' Affairs Interim Committee under section [5-5-228](#), MCA.

**Poll of the Legislature**

The State Administration and Veterans' Affairs Interim Committee conducted a poll of the members of the Legislature on each of the 16 rules objected to by more than 20 legislators, including New Rules I, IV through VIII, and X through XII, and the amendment of ARM 44.10.201, 44.10.301, 44.10.307, 44.10.321, 44.10.323, 44.10.327, and 44.10.329, starting on December 1, 2015, and ending on December 21, 2015, at midnight. ## Potential Impact of the Poll Results

Section 2-4-404, MCA, provides that the results of an interim committee poll must be admissible in any court proceeding involving the validity of the proposed rule. It provides further that if a majority of the members of both houses find that the proposed rule or adopted rule is contrary to the intent of the legislature, the proposed rule or adopted rule must be conclusively presumed to be contrary to the legislative intent in any court proceeding involving its validity.
