SUBJECT: Air quality operation fees

NOTICE DESCRIPTION: Notice of Public Hearing on Proposed Amendment

SUMMARY OF RULE: The Board of Environmental Review (board) is proposing an amendment to air quality operation fees. The proposed amendment increases the administrative fee from \$800 to \$900, the tonnage fee amount from \$38.24 to \$45.37 per ton, and the air quality operation fee for registered oil and gas well facilities increase from \$800 to \$900. The board reasons that the proposed fee increase will allow the air quality bureau to collect sufficient revenue to implement the Department of Environmental Quality's air quality program. The last time the board raised air quality operation fees was in 2009.

NOTES: On July 13, 2018, at 1:00 p.m., the board will hold a public hearing on this proposed amendment in Room 111 of the Metcalf Building, 1520 East Sixth Avenue, Helena, Montana.
