concerning integrated resource planning; two bills drafts concerning qualifying facilities; the small water 2 bill draft; and the final reports: HJ 28 Natural Gas Customer Choice (Exhibit 20) and SJ 31 Utility Decoupling (Exhibit 21) that will be finalized. He referred the committee to the "Understanding Energy Guide"

that was distributed at noon.
