# **COMMITTEE ACTIONS**

- Approved as a committee bill LCVFF3 with a fireworks tax generating up to \$250,000 per year designated for assisting local fire agencies with workers' compensation for volunteer fire fighters and the remainder of the revenue for emergency medical and trauma services grants, an effective date of October 1, 2019, and a termination date of September 30, 2023. Rep. Dunwell agreed to carry.
- Approved as a committee bill LC VFF1 sections 1, 6, 9, 12 unanimously with the addition of language that says the mandatory volunteer firefighters' workers' compensation requirement would start in 2021. Sen. Thomas agreed to carry.
- Approved 7-1 as a committee bill LCVFF2, allowing emergency care providers to offer community-integrated health care. Sen. MacDonald agreed to carry.
- Approved as a committee bill LCMFD3 to allow certain municipalities to annex onto a rural fire district with changes to reflect an affirmative vote for a simple majority of those voting on the question in the proposal. Senator Webb agreed to carry.
- Approved as a committee bill LCMFD4 authorizing creation of regional fire protection service authorities with technical changes to be recommended by the Montana League of Cities and Towns, Montana Association of Counties, and stakeholders for consistency in dissolution and approval processes. Sen. MacDonald agreed to carry.
- Approved as a committee bill LCLGR1 allowing government accounting standards to include a financial reporting framework as defined by the department of administration. Sen. MacDonald agreed to carry.
- Adopted the Senate Joint Resolution No. 21 draft final report "Preserving and Improving the Future of Volunteer Fire and Emergency Services in Montana" with changes to reflect actions taken by the committee in July.
