Exceptions Granted to State Agencies (2-17-515, MCA) (October 2019 – December 2019)

- 1. State CIO, Tim Bottenfield sent:
 - a. COR Director, Reginald Michael a conditional approval letter for an exception request to Executive Order 09-2106 on October 10, 2019.
 - b. OPD Director, Rhonda Schaffer a denial letter for an ITPR Policy on October 30, 2019. VLC was put on the banned software list and it was removed from State PCs on 10/1/2019. This exception request was in conjunction with an ITPR request to receive an extension to use VLC Media Player.
 - c. HIS Director, Bruce Whittenberg an approval letter for an exception to Section IV (Requirements) of the Online Electronic Payment Processing Policy, stating "All online collection of funds shall use the State Electronic Payment Processing portal on October 17, 2019.
 - d. OPD Director, Rhonda Schaffer a denial letter to STD-Identification and Authentication Standard, B-8 unless they worked with NTSB "Zoom Team" to develop a solution using the enterprise accepted conferencing tools on September 4, 2019. SITSD completed a review of the OPD Zoom Workstation System Security Plan (SSP) that adheres to State of Montana Risk Management Framework (RMF) Standard requirements. The risk was marked as "Low" and a letter with this assessment was sent to Director Schaffer on November 20, 2019.
 - e. HHS Director, Sheila Hogan an approval letter for an exception to paying for extended support and not isolate systems with unsupported software (Windows Server 2008R2 and SQL2008 are at end of life) on December 23, 2019. To date, HHS has not used the exception request and we do not expect them to do so as they purchased extended support.
 - f. STF President, Laurence Hubbard a conditional approval letter for an exception to directive number 3 of Executive Order 09-2016 on December 24, 2019.
