## JUNE FY 2016 BUDGET STATUS REPORT (Exhibit 1)

00:02:31 Susie Lindsay, Communications Supervisor, Legislative Fiscal Division (LFD) gave an update on the general fund ending balance and discussed the General Fund Variable shifts shown in the graph on page 2.

#### Revenues

- 00:05:46 Stephanie Morrison, Fiscal Analyst, LFD gave a brief update on Year-to-Date Revenue collections and discussed the major sources in revenue.
- O0:14:33 Sam Schaefer, Fiscal Analyst, LFD discussed the 33.7% decrease in Corporation Income Tax and reasons for the decrease. He also discussed the Vehicle Fees & Taxes source which is above the estimate at this time. The Oil & Natural Gas Production Tax is currently below estimate at this time and Mr. Schafer discussed the reasons why this decrease has occurred. Video Gaming Tax is slightly below the HJ 2 forecast.
- O0:21:40 Alice Hecht, Fiscal Analyst, LFD presented the Insurance Tax growth which has been slower than expected. HJ 2 anticipates growth of 8.6% at fiscal year end.

Currently the State Auditor's Office is researching to understand the discrepancy.

00:23:16 Nick VanBrown, Fiscal Analyst, LFD discussed the Property Tax which is currently in line with the estimate. It is above last year by \$4.7 million or 3.1% and currently above the HJ 2 estimated growth of 2.4%, but final collections will likely come close to HJ 2 estimates.

## **Budget and Expenditures**

- 00:26:00 Kris Wilkinson, Fiscal Analyst, LFD explained the budget and expenditure portion of the report that discusses the FY 2016 appropriations and related expenditures by budget section. Ms. Wilkinson also discussed the request for transfer of funding from FY 2017 to FY 2016 within the Dept. of Justice and possible committee actions regarding the transfer. Ms. Wilkinson also gave brief introduction and summarization of Section A General Government.
- O0:32:16 Stephen Forrest, Fiscal Analyst LFD discussed changes in Section C- Natural Resources and Transportation. There are declining revenues in natural resources especially within the Natural Resource Operations Account.
- O0:34:12 Greg Dewitt, Fiscal Analyst. LFD discussed changes in Section D Judicial Branch, Law Enforcement, and Justice. The Department of Justice requested a transfer of \$570,000 from FY 2017 to FY 2016 for a budget shortfall in the Forensic Science Division. - 00:56:14 Rob Miller, Fiscal Analyst, LFD summarized changes in Section E Education. The Office of Public Instruction has expended \$10.4 million of its general fund appropriation. Appropriations for BASE Aid are anticipated to exceed forecasted payments in FY 2016 by \$1.0 million. Additionally, LFD estimates for FY 2017 that the guarantee account revenues will be approximately \$7.4 million less than those anticipated in HJ 2. The Office of the Commissioner of Higher Education moved \$0.1 million general fund appropriation authority from FY 2017 to FY 2016 in the Student Assistance Program.
- 00:59:11 Cathy Duncan, Fiscal Analyst, LFD gave a brief summary of Section F Long-Range Planning. The programs within Section F are generally funded out of dedicated natural resource revenues.
