Outline of Staff Issues and Options Paper #1: Selecting Options for Further Consideration

*NOTE: Options will be further defined and developed in conjunction with an SJR 5 Working Group meeting on November 9 and through the discussion panels at the meeting. Also, there are other issues and options that staff will further outline and present at the Thursday, November 15, 2001, meeting during the staff presentation scheduled for 4:45 p.m.

Outreach and communication: Is there a significant problem with coordinated outreach to veterans? If so, what are the roots of this problem? Is there a state role in improving coordinated outreach to veterans? If so, what approaches should be further explored by the Subcommittee as possible recommendations?

OPTIONS:

- A. Encourage local level and veteran service organization efforts, but take no defined state legislative action
- B. Establish a statewide outreach and coordination committee or advisory council to develop a strategic plan
- C. Designate the Board of Veterans Affairs as the lead agency in statute to work with various people and programs to develop and coordinate outreach and communication programs
- D. Establish a Department of Veterans Affairs, make the Director a cabinetlevel official directly accountable to the Governor and on equal footing with other state departments. Delineate in statute its roles and responsibilities.
- E. Make the Department of Military Affairs the lead agency for Veterans' Affairs.
- F. Others?

Interagency coordination, collaboration, cooperation: Is there a significant problem with interagency coordination, collaboration, and cooperation? If so, what causes the problem? Is there a state role in addressing the problem? If so, what approaches should be further explored?

- A. Encourage coordination and cooperation among agencies, but without specific state legislation
- B. Establish an inter-agency coordinating council or advisory council or create a state veterans service coordinator position (similar to the coordinator on Indian Affairs or a coordinator for specific activities such as a state homeless veteran stand down coordinator)
- C. Direct the Board of Veterans Affairs to establish collaborative interagency agreements
- D. Establish a Department of Veterans Affairs, make the Director a cabinetlevel official directly accountable to the Governor and on equal footing with other state departments. Delineate in statute its roles and responsibilities.
- E. Make the Department of Military Affairs the lead agency for Veterans' Affairs.
- F. Others?

Problem solving: Is there a problem with "passing the buck" or with agencies not having clearly defined responsibilities so that when a veteran encounters problems with "the system" they fall through the cracks? If so, what causes the problem? Is there a state role in addressing the problem? If so, what approaches should be further explored?

- A. Encourage coordination and cooperation among agencies, but without specific state legislation
- B. Establish a veterans' ombudsman-type position.
- C. Direct the Board of Veterans Affairs to create a "case management" program within the MVAD that will augment the benefit claims process, but which will be responsible for helping veterans identify current programs and to navigate through them, similar to a resource and referral program.
- D. Establish a Department of Veterans Affairs, make the Director a cabinetlevel official directly accountable to the Governor and on equal footing with other state departments. Delineate in statute its roles and responsibilities.
- E. Make the Department of Military Affairs the lead agency for Veterans' Affairs.
- F. Others?
