Fiscal Analysis

ASSUMPTIONS:

- 1. The position of the Asbestos Claims Judge and the court reporter would be filled using contracted services. There would also be 1.00 FTE required for a combination secretary/law clerk.
- 2. A vehicle would be leased for the court at a cost of \$5,000 per year.
- 3. The judge would make three trips per year for three weeks at a time, and one trip per month for three nights each. The average round trip would be 680 miles.
- 4. Two computers, one printer and one fax machine would be purchased in the first year only.

- 5. The Asbestos Claims Court would not rent additional office space. Space would be borrowed from existing courts.
- 6. The court reporter will charge for transcripts, not to exceed statutory limits.
- 7. Lincoln County has agreed to pay for \$15,000 per year of costs incurred by this court.
- 8. The Judiciary is currently investigating the possibility of obtaining federal money to fund this court. If federal funds are obtained, a like amount of general fund may be reverted.
