12	NEW SECTION. Section 1. Disposition of civil fines, costs, and fees. (1) All civil fines, costs, and
13	fees received or recovered by the department pursuant to this part must be deposited into a state special
14	revenue account to the credit of the department and must be used to defray the expenses of the department in
15	discharging its administrative and regulatory powers and duties in relation to this part. Any excess civil fines,
16	costs, or fees must be transferred to the general fund.
17	(2) All civil fines, costs, and fees received or recovered by the attorney general pursuant to this part
18	must be deposited into a state special revenue account to the credit of the attorney general and must be used
19	to defray the expenses of the office of the attorney general in discharging its regulatory powers and duties in
20	relation to this part. Any excess civil fines, costs, or fees must be transferred to the general fund.
21	(3) All civil fines, costs, and fees received or recovered by a county attorney pursuant to this part must
22	be paid to the general fund of the county where the action was commenced.

24	NEW SECTION. Section 2. Disposition of civil fines, costs, and fees. (1) All civil fines, costs, and
25	fees received or recovered by the department pursuant to this part must be deposited into a state special
