Section 1. Counting votes for candidate nominated by more than one party. In 14 a general election, votes for an individual whose name appears on the ballot more than once, as provided in 15 13-12-203, including votes cast for the individual as a write-in candidate, must be totaled. The aggregate number 16 of votes received by the individual, irrespective of party affiliation, must be used in determining the winner of the 17 election. 18 19 **Section 2.** Section 13-12-203, MCA, is amended to read: 20 "13-12-203. Printing of candidate's name and party designation on ballot. (1) (a) Except as 21 provided in 13-10-209 and 13-10-303, in partisan elections, candidates' names shall must be printed under the 22 title of the office sought, with the name of the party, in not more than three words, or "Independent" printed 23 opposite the name. 24 (b) In a general partisan election, if an individual is a candidate representing more than one party, the 25 individual's name must appear once for each party for which the individual is the nominated candidate. 26 (2) In nonpartisan elections, the candidates' names shall must be printed under the title of the office 27 sought, with no description or designation printed with the name unless partisan and nonpartisan offices appear 28 on the same ballot. In such a that case, the names of nonpartisan candidates shall must have printed with them 29 the words "Nominated without party designation"."
