12	NEW SECTION. Section 1. Standards for recorded documents. (1) Unless accompanied by the

15	(a) be <u>LEGIBLY</u> printed or typed in black ink in at least 10-point typeface, <u>NOT INCLUDING THE SIGNATURE</u> ,
16	on white paper of not less than 20-pound weight, each page of which must be separated and have dimensions
17	of either 8 1/2 x 11 inches or 8 1/2 x 14 inches;
18	(b) provide the legal names of the parties to the conveyance on the first OR SECOND page of any
19	document with more than one page;
20	(c) provide a description of the property, which must include the following information:
21	(i) the name of the county and the sections, townships, and ranges, all of which must be spelled in full,
22	where the property is located; and
23	(ii) aliquot parts descriptions of the property;
24	(iii) a lot, tract, or parcel designation and the number of a filed certificate of survey;
25	(iv) a lot and block designation and the name or number of a filed subdivision plat;
26	(v) a lot, tract, or parcel designation and the number of a filed corner recordation plat; or
27	(vi) a metes and bounds description of the perimeter boundary, only if the property has previously been
28	transferred by a recorded document containing the same description and if that description has not been
29	superseded by one of the filed survey documents provided in subsections (1)(c)(iii) through (1)(c)(v);
30	(I) THE COUNTY, A LOT, TRACT, OR PARCEL DESIGNATION, AND THE NUMBER OF A FILED CERTIFICATE OF SURVEY;

1	(II) THE COUNTY, A LOT AND BLOCK DESIGNATION, AND THE NAME OR NUMBER OF A FILED SUBDIVISION PLAT;
2	(III) THE COUNTY, A LOT, TRACT, OR PARCEL DESIGNATION, AND THE NUMBER OF A FILED CORNER RECORDATION
3	<del>PLAT; OR</del>
4	(IV) THE COUNTY AND THE SECTION, TOWNSHIP, AND RANGE, ALL OF WHICH MUST BE SPELLED OUT IN FULL, AND
5	ONE OF THE FOLLOWING:
6	(A) AN ALIQUOT PARTS DESCRIPTION OF THE PROPERTY; OR
7	(B) A METES AND BOUNDS DESCRIPTION OF THE PERIMETER BOUNDARY, BUT ONLY IF THE PROPERTY HAS
8	PREVIOUSLY BEEN TRANSFERRED BY A RECORDED DOCUMENT CONTAINING THE SAME DESCRIPTION AND THAT
9	DESCRIPTION HAS NOT BEEN SUPERSEDED BY ONE OF THE FILED SURVEY DOCUMENTS PROVIDED FOR IN SUBSECTIONS
10	(1)(c)(I) THROUGH (1)(c)(III);
11	(d) except as provided in subsection (1)(e) AND EXCEPT FOR PAGE NUMBERS OR OTHER DESIGNATIONS, have
12	margins that are clear of all markings in the following dimensions:
13	(i) AT LEAST 3 inches at the top of the first page and AT LEAST 1 inch at the top of the second and any
14	subsequent pages; and
15	(ii) AT LEAST 1 inch on the sides and bottom of each page; and
16	(e) include the name and mailing address of the person to whom the document is to be returned in the
17	margin in the upper left-hand corner of the first page of each document submitted AND MAY INCLUDE LEGIBLY
18	PRINTED OR TYPED TRANSACTIONAL INFORMATION.
19	(2) Unless accompanied by the fee required in [section $\frac{3(2)}{2}$ ], all other documents submitted for
20	recording must meet the requirements of subsections (1)(a), (1)(d), and (1)(e).
21	(3) (a) Except as provided in subsection (3)(b), only documents submitted for recording and filing that
22	conform to the provisions of subsection (1) or (2) are considered standard documents for the purposes of
23	[section $\frac{3}{2}$ ].
24	(b) Documents that are notarized ACKNOWLEDGED as having been executed prior to [the effective date
25	of this act] must be accepted for recording and considered standard documents, regardless of whether they
26	conform to the provisions of subsection (1) or (2).
27	
28	NEW SECTION. Section 2. Filed documents. (1) A county clerk may accept for filing only the
29	following documents:
30	(a) subdivision plats and amended subdivision plats;

1	(b) certificates of survey, amended certificates of survey, and certified corner recordation forms;
2	(c) financing statements and amended financing statements under Title 30, chapters 1 through 5, 7,
3	8, and 9A;

5	(e) any other document allowed by law to be filed.
6	(2) A clerk may accept a document that is not listed in subsection (1) only for recording.
7	
8	NEW SECTION. Section 2. Fees for recording standard documents. (1) Except as provided in
9	7-4-2631 AND SUBSECTION (2) OF THIS SECTION, the fee for recording a standard document that meets the
10	requirements of [section 1] is \$6 for each page or fraction of a page.
11	(2) The fee for recording a document that does not meet the requirements of [section 1] is $\$25$ $\$10$ for
12	each page or fraction of a page FOR THE FIRST FIVE PAGES OR FRACTIONS OF THE PAGES AND \$6 FOR EACH
13	SUBSEQUENT PAGE.
14	(3) Any fee collected under subsection (2) must be deposited in the records preservation fund
15	PROVIDED FOR IN 7-4-2635. THE FEES COLLECTED UNDER SUBSECTION (2)
16	(A) OF THE FEES COLLECTED UNDER SUBSECTION (1), \$1 MUST BE DEPOSITED IN THE RECORDS PRESERVATION
17	FUND, PROVIDED FOR IN 7-4-2635, AND THE REMAINDER MUST BE DEPOSITED AS PROVIDED FOR IN 7-4-2511.
18	(B) OF THE FEES COLLECTED UNDER SUBSECTION (2) FOR NONSTANDARD DOCUMENTS, EACH \$6 AMOUNT FOR
19	A PAGE OR FRACTION OF A PAGE MUST BE DEPOSITED AS PROVIDED FOR IN SUBSECTION (3)(A). THE REMAINING \$4 OF
20	EACH \$10 CHARGE FOR A PAGE OR FRACTION OF A PAGE MUST BE DEPOSITED IN THE RECORDS PRESERVATION FUND.

25	Section 3. Section 7-4-2631, MCA, is amended to read:
26	"7-4-2631. Fees of county clerk. (1) Except as provided in 7-4-2632 AND [SECTION 3(2) 2], the county
27	clerks shall charge, for the use of their respective counties:
28	(a) for recording and indexing each certificate of location of a quartz or placer mining claim or millsite
29	claim, including a certificate that the instrument has been recorded with seal affixed, \$6;
30	(b) for recording and indexing each affidavit of annual labor on a mining claim, including certificate that

- 1 the instrument has been recorded with seal affixed:
- 2 (i) for the first mining claim in the affidavit, \$3; and
- 3 (ii) for each additional mining claim included in it, 50 cents;
  - (c) for filing and indexing each writ of attachment, execution, certificate of sale, lien, or other instrument required by law to be filed and indexed, \$5;
- 6 (d) for filing of subdivision and townsite plats, \$5 plus:
- 7 (i) for each lot up to and including 100, 50 cents;
- 8 (ii) for each additional lot in excess of 100, 25 cents;
- 9 (e) for filing certificates of surveys and amendments thereto, \$5 plus 50 cents per tract or lot;
- 10 (f) for a copy of a record or paper:

- 11 (i) for the first page of any document, 50 cents, and 25 cents for each subsequent page; and
- 12 (ii) for each certification with seal affixed, \$2;
- (g) for searching an index record of files of the office for each year when required in abstracting orotherwise, 50 cents;
  - (h) for administering an oath with certificate and seal, no charge;
- 16 (i) for taking and certifying an acknowledgment, with seal affixed, for signature to it, no charge;
  - (j) for filing, indexing, or other services provided for by Title 30, chapter 9A, part 5, the fees prescribed under those sections;
    - (k) for recording each stock subscription and contract, stock certificate, and articles of incorporation for water users' associations, \$3;
  - (I) for filing a copy of notarial commission and issuing a certificate of official character of such notary public, \$2;
    - (m) for each certified copy of a birth certificate, \$5, and for each certified copy of a death certificate, \$3;
- 24 (n) for filing, recording, or indexing any other instrument not expressly provided for in this section or 7-4-2632, the same fee provided in this section or 7-4-2632 for a similar service.
  - (o) for recording a document that does not meet the requirements of [section 1], \$25 for each page or fraction of a page, as provided in [section 3(2)].
  - (2) State agencies submitting documents to be put of record shall pay the fees provided for in <u>fsection</u> 31 or this section. If a state agency or political subdivision has requested an account with the county clerk, any applicable fees must be paid on a periodic basis."
