2	INTRODUCED BY LEWIS, COHENOUR, GALLIK, JACOBSON
3	
4	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF
5	MONTANA URGING THE CITY OF HELENA LEWIS AND CLARK COUNTY TO WORK COOPERATIVELY
6	WITH THE BOARD OF REGENTS TO SECURE FINANCING FOR A NEW BUILDING AT THE HELENA
7	COLLEGE OF TECHNOLOGY OF THE UNIVERSITY OF MONTANA BY ISSUING BONDS TO FINANCE THE
8	CONSTRUCTION OF THE PROJECT AND TO ENTER INTO AN AGREEMENT TO LEASE THE FACILITY,
9	UPON COMPLETION, TO THE BOARD OF REGENTS <u>UNTIL THE BONDS ARE RETIRED</u> .

11	WHEREAS, pursuant to Article X, section 9(2), of the Montana Constitution, the Board of Regents has
12	full power, responsibility, and authority to supervise, coordinate, manage, and control the Montana University
13	System and the authority to supervise and coordinate other public educational institutions as assigned by law
14	and
15	WHEREAS, in 1995 the Board of Regents restructured the University System by incorporating the
16	vocational-technical centers and the 1995 Legislature enacted Chapter 308, Laws of 1995 (Senate Bill No. 156),
17	to statutorily assign the vocational-technical centers to the Board to supervise and coordinate; and
18	WHEREAS, the Board of Regents has sufficient authority to use private money to construct buildings
19	and to enter into contractual arrangements with self-governing local governments to work together on mutually
20	beneficial projects; and
21	WHEREAS, since the Helena College of Technology of the University of Montana is located in Helena
22	and supports the economy of the local region, the City of Helena LEWIS AND CLARK COUNTY has a vested interest
23	in working with the Board of Regents to secure a new building for the college.
24	
25	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF
26	THE STATE OF MONTANA:
27	That the City of Helena LEWIS AND CLARK COUNTY be strongly urged to work cooperatively with the Board
28	of Regents to secure financing for a new building at the Helena College of Technology of the University of
29	Montana by issuing bonds to finance the construction of the project and to enter into an agreement to lease the
30	facility, upon completion, to the Board of Regents <u>UNTIL THE BONDS ARE RETIRED</u> .
