14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

16	Section 1. Section 69-8-412, MCA, is amended to read:
17	"69-8-412. Funds established fund administrators designated purpose of funds department
18	rulemaking authority to administer funds. (1) If, pursuant to 69-8-402(2)(f) or (5)(b), there is any positive
19	difference between credits and the annual funding requirement, the department of revenue shall establish one
20	or both of the following funds:
21	(a) a fund to provide for universal system benefits programs other than low-income energy assistance.
22	The department of environmental quality shall administer this fund.
23	(b) a fund to provide universal low-income energy assistance. The department of public health and
24	human services shall administer this fund.
25	(2) The purpose of these funds is to fund universal system benefits programs.
26	(3) The department of environmental quality and the department of public health and human services
27	shall expend the money in each representative fund on universal system benefits programs in the utility service
28	territory from which the money was received.
29	$\frac{3}{4}$ The department of environmental quality and the department of public health and human services
30	may adopt rules that administer and expend the money in each respective fund based on an annual statewide
