| 11 | Section 1. Section 41-5-121, MCA, is amended to read:  |
| 12 | "41-5-121. Youth placement committees composition. (1) In each judicial district, the youth court                |
| 13 | and the department shall establish a youth placement committee for the purposes of:                              |
| 14 | (a) recommending an appropriate placement of a youth referred to the youth court or the department               |
| 15 | under 41-5-1512 and 41-5-1513; or  |
| 16 | (b) recommending available community services or alternative placements whenever a change is                     |
| 17 | required in the placement of a youth who is currently in the custody of the department under 41-5-1512 or        |
| 18 | 41-5-1513. However, the committee may not substitute its judgment for that of the superintendent of a state      |
| 19 | youth correctional facility regarding the discharge of a youth from the facility.                                |
| 20 | (2) (a) The committee consists of not less than five members and must include persons who are                    |
| 21 | knowledgeable about the youth, treatment and placement options, and other resources appropriate to address       |
| 22 | the needs of the youth.  |
| 23 | (b) The committee must include:  |
| 24 | (i) a juvenile parole officer employed by the department;  |
| 25 | (ii) a representative of the department of public health and human services;                                     |
| 26 | (iii) the chief probation officer or the chief probation officer's designee, who is the presiding officer of the |
| 27 | committee;   |
| 28 | (iv) a mental health professional; and   |
| 29 | (v) if an Indian youth is involved, a person, preferably an Indian, knowledgeable about Indian culture           |
