6	THE PURPOSE OF POPULATION EQUALITY; PROVIDING FOR TRANSITION; AND AMENDING SECTION
7	69-1-104, MCA."

9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 69-1-104, MCA, is amended to read:
12	"69-1-104. Public service commission districts. In this state there are five public service commission
13	districts, with one commissioner elected from each district, distributed as follows:
14	(1) first district: Blaine, <u>Cascade,</u> Chouteau, Daniels, Dawson, Fergus, Garfield, Glacier, Golden Valley,
15	Hill, Judith Basin, Liberty, McCone, Musselshell, Petroleum, Phillips, Pondera, Prairie, Richland, Roosevelt,
16	Sheridan, Toole, and Valley , and Wibaux<u>, AND WIBAUX</u> Counties;
17	(2) second district: Big Horn, Carbon, Carter, Custer, Fallon, Musselshell, Powder River, Prairie,
18	Rosebud, Stillwater, Sweet Grass, Treasure, Wibaux, and Yellowstone Counties;
19	(3) third district: <u>Beaverhead,</u> Broadwater, Cascade, <u>Deer Lodge, Gallatin, Golden Valley,</u> Jefferson,
20	Judith Basin, Lewis and Clark, Madison, Meagher, Teton, MUSSELSHELL, Park, Silver Bow, Stillwater, Sweet
21	<u>Grass,</u> and Wheatland Counties;
22	(4) fourth district: Beaverhead, Deer Lodge, Gallatin, Granite, Madison, Park, <u>Lake</u> LINCOLN, Mineral,
23	Missoula, Powell, Ravalli, and Silver Bow <u>Sanders</u> Counties;
24	(5) fifth district: Flathead, Lake, <u>Glacier, LAKE, Lewis and Clark, Lincoln, Mineral, Missoula, and Sanders</u>
25	Pondera, and Teton Counties."

27	NEW SECTION. Section 2. Transition. For the purposes of the 2004 election, the secretary of state
28	shall declare which district a sitting commissioner represents for any public service commissioner whose district
29	is not up for election and shall use as criteria the residence of the respective commissioner on [the effective date
30	of this act].
