7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

9	NEW SECTION. Section 1. Waste tire bales BALED WASTE TIRES prohibited exception
10	DEPARTMENT RULES. (1) Waste tires that are mechanically compressed or baled and bound together with cable,
11	straps, wires, or other nonpermanent mechanical devices may not be used for any aboveground purpose unless
12	they are encased in concrete or a similar material that will maintain the integrity of the bale upon failure of the
13	bale restraining devices AS A BOUNDARY FENCE BETWEEN ADJACENT PRIVATE PROPERTIES FOR ANY ABOVEGROUND
14	PURPOSE WITHIN 500 FEET OF ANY ROAD, COMMERCIAL BUSINESS, OR PRIVATE RESIDENCE WITHOUT THE CONSENT OF
15	THE OWNER OF THE BUSINESS OR RESIDENCE UNLESS THEY ARE ENCASED IN CONCRETE OR A SIMILAR A MATERIAL THAT
16	WILL MAINTAIN THE INTEGRITY OF THE BALE UPON FAILURE OF THE BALE RESTRAINING DEVICES. NOTWITHSTANDING ANY
17	OTHER PROVISION OF LAW, THE DEPARTMENT SHALL ADOPT RULES AUTHORIZING OTHER ABOVEGROUND USES FOR BALED
18	WASTE TIRES, WHETHER OR NOT THEY ARE DEFINED AS SOLID WASTE.
19	(2) Waste tire bales BALED WASTE TIRES, as described in subsection (1), may not be placed under water
20	under any circumstances BE USED ONLY IN COMMERCIAL APPLICATIONS SUCH AS SOIL EROSION CONTROL, RETAINING
21	WALLS, CORRALS, INTERIOR FENCING, SAFETY USES, STREAMBANK STABILIZATION, OR STATE CIVIL ENGINEERING
22	PROJECTS NOT BE PLACED UNDER WATER UNDER ANY CIRCUMSTANCES OR IN A LOCATION WHERE THEY ARE LIKELY TO
23	ENTER ANY STATE WATERS.
24	(3) A BALE OF WASTE TIRES THAT LOSES ITS INTEGRITY IS SOLID WASTE AND IS SUBJECT TO DISPOSAL
25	REQUIREMENTS AND PENALTIES AS PROVIDED IN THIS PART.

27	NEW SECTION. Section 2. Codification instruction. [Section 1] is intended to be codified as an
28	integral part of Title 75, chapter 10, part 2, and the provisions of Title 75, chapter 10, part 2, apply to [section 1].

30	NEW SECTION. Section 3. Saving clause. [This act] does not affect rights and duties that
