How do I notify Devon Energy of a change in my address?

Change of address requests must be made in writing to the address above, Attention: Owner Relations Hotline. Please include your name, owner number, old address, new address, Tax ID/Social Security Number, and a phone number where we can reach you. If you would like us to send you a form, please call our Owner Relations Hotline.

What should I do if I don't receive my royalty check?

Due to potential postal delays, a check may arrive a few days late. If your check is more than two weeks late, please contact our Owner Relations Hotline so that we can research the issue.

What should I do if I don't receive my check detail?

Please call our Owner Relations Hotline for a temporary password for Oildex Owner Connect to view and print your check detail on-line. If you do not have access to a computer, please call our Owner Relations Hotline and we will mail or fax you a copy of your detail.

When are royalty checks mailed each month?

Your royalty check will be mailed on the 15th of the month or the first workday after if the 15th falls on a weekend or holiday.

Does Devon Energy offer Direct Deposit (Electronic Funds Transfer)?

Yes. If you would like to receive your royalty payments via direct deposit, please call our Owner Relations Hotline and a form will be mailed or faxed to you. The ACH settlement date is two banking days after the effective date.



Frequently Asked Questions

What is Devon Energy's "Minimum Suspense" policy?

Royalty payments may be deferred to a later payment date, until the amount owed reaches a threshold. This threshold is called the "minimum suspense amount." When the amount owed reaches \$100.00, the royalty payment is processed. In June of each year, all funds totaling \$10.00 or more will be released from "minimum suspense."

Why does the amount of my royalty payment change from month to month?

Changing market conditions can cause price fluctuations, while mechanical or operational problems or routine maintenance may temporarily affect production, causing downtime. If you have reason to believe an error has occurred, please contact our Owner Relations Hotline.

On what basis are volumes reported on my check detail?

If volumes are derived from processed gas, you will see residue gas in MCF and natural gas liquids (NGLs) in barrels. If your product is not processed, then your volumes will be reported in MCF for gas and barrels for oil/condensate.

What should I do when the owner of record passes away?

If the deceased party left a Will and the Will is being probated, provide us with a copy of the Will, death certificate, Letters Testamentary, and Final Decree of Distribution. If the estate is not probated, provide us with a copy of the Will (if available) and death certificate. Our Division Order Department will contact you if more documentation is required.

How do I change my name in the event of a marriage or divorce?

Provide a court certified copy of Marriage Certificate or Divorce Decree and state you want your name changed FROM... TO... Advise if you want interest suspended or continue payment as is until transaction is complete.

How do I put my interest into a Trust?

Prepare or have prepared a Memorandum of Trust and a conveyance document from the current owner of record into the Trust. Have the documents recorded in the county and state where the minerals reside. Provide the tax identification number of Trust and telephone number and address if applicable. Advise if owner wants the interest suspended or continue payment as is until transaction is complete.



Frequently Asked Questions

How do I transfer my ownership to someone else?

Provide an assignment or deed document of conveyance that has been recorded in the county and state where the minerals reside. Provide the social security number of new payee, address and daytime telephone number. Advise if owner wants interest suspended or continue payment as is until transaction is complete.

How do I notify Devon Energy of a change in Trustee?

Provide that portion of the Trust document that determines who is successor Trustee as well as the duties and powers of the Trustee and circumstances leading to replacement of Trustee, and let us know if an address change is also needed.

I would like to add my spouse to my account. How do I do this?

Provide a conveyance document establishing joint ownership that has been recorded in the county and state where the minerals reside. Advise if you want the interest suspended or continue payment as is until transaction is complete.
