

EXECUTIVE SUMMARY
"Montana Disaster & Emergency Plan"

The "Montana Disaster and Emergency Plan", authorized by Montana Code Annotated (MCA) Title 10, Chapter 3, Part 301; will be comprised of the Emergency Coordination Plan (ECP) and the necessary operational plans for coordinating functional capabilities, incident specific coordination issues or recovery implementation plans. The ECP and operational plans will be stand-alone documents and considered volumes of the "Montana Disaster and Emergency Plan". The ECP will be the main coordinating and policy document for all plans. The operational plans will establish the Standard Operating Procedures (SOP) for the subject of the volume. The lead agency for each plan will be responsible for updating the plan and managing the distribution. Disaster and Emergency Services (DES) will assist the lead and support agencies in coordinating the operational plan development. A copy of all volumes will be housed in the DES Plan Library. DES will maintain a record of all plan distribution lists and updates.

The following table identifies the volumes of the "Montana Disaster and Emergency Plan" and the lead agency/agencies. The shaded sections denote those volumes that are in the developmental stage.
