My name is Doug Amsden.

I am an alienated traumatic brain injured and physical disabled recipient of a state agency who lives in HD 55 and SD 28.

I complain that I am a post-traumatic-brain-injured and indigent person who is lost his inalienable right for social investment because I am negligently under served by aggressive administration culture performance issues with the Montana Vocational Rehabilitation policy

I recently filed my appeal for Constitution redress with the Montana Supreme Court

I believe that my reported work potential to form a culture alliance for liaison service is been subject to official libel and slander

I, therefore, ask this bipartisan Legislative Appropriations Subcommittee to fund the 2005 Legislative Audit Committee investigation on the Montana Vocational Rehabilitation program human resource management standards set upon preservation in the 2003 Montana Code Annotated statute

The state agency reneged upon its initial written declaration to provide my endorsed business plan with economic and technology resource assistance

By this relationship my innovative rehabilitation business proposal on the disclosure of practical arts and science market tools in individualized job placement assistance were physically displaced

Upon my having to become a whistleblower in order to protect honoring the disadvantaged culture civil rights

I advocate the educational program transfer of fundamental English language translation proponents for rehabilitation organization transformation

Far too many similar situated disabled recipients are unnecessarily dependent while being denied a meaningful agency assessment upon these basic industry manufacturing rights

I have corresponded to various state agency requests on providing economic resource supplements in transition and worked numerous hours over 16+ years without recognition on my help to provide a strategic rehabilitation pro labor production and tax incentive service program initiative on the implementation and commercial development of complimentary welfare reform market issues

My timely report with this multipurpose business plan included at least two distinguished official endorsements and a handwritten President's Committee Chairman recommendation on provisions with state assistance provided on the agency Individualized Plan on Employment (IPE) program to market my diverse rehabilitation information-technology management pilot project program agenda

But my individualized work and requests for rehabilitation service assistance provisions to remedy the discrimination upon adverse resource accommodations provided in agency IPE program negotiations fell on deaf ears

These assigned agent response on my behalf was non-complaint

By example: such an inefficient and inarticulate rehabilitation work ethic on my behalf is fraudulent in nature

This systemic inaction on raising the public education, health and welfare poverty status connotes a Welfare State hidden agenda and conspiracy

When I completed my work on back-to-basics rehabilitation communications issues provided with job placement assistance either I'd be re-assigned a new agent or my case file would be closed

I appealed this rehabilitation misrepresentation case scenario but was given no immediate justice for redress

I am disenfranchised by our government agencies contempt

While I wait now to receive this Montana Supreme Court decision

The assessment given by assigned agent failed to specify alternative representation recommendations within reports to exemplify my industry job placement assistance

I naturally voiced my frustration to these agents and asked them to reconsider their placement assistance objectives on my behalf

I was earlier informed by one agent that if I felt I had been wronged by the agency that I had to prove it

My individual dignity, integrity and self-esteem is subject to educational falsification and non-compliance

And because I would not comply and compromise my individualized request for industry job placement assistance

The agent unwillingness to procedurally compromise with job placement assistance provisions on my behalf is led itself to my suffering humiliation, intimidation, harassment and post-traumatic stress

I also provide this testimony to represent similar situated disabled recipient's entitlement for economic freedom

With this associated characterization on the restoration of freedom my individualized rights in production are handicapped by this state government's artificial behavior

My Montana Constitution First Amendment Freedom of Expression rights are jeopardized by the administration culture's superficial conduct

The state agency unfairly manipulated my aptitude tests and scores upon the rehabilitation English language which was reported on preserving my mental interests and physical production strength

The disorganized and complacency of this state office further failed to broaden my rehabilitation industry manufacturing horizons

The prehistoric agency service agenda on my behalf instead provided me with placement assistance without accommodating the employment placement assistance information upon my educational ability and physical strength

This is a misrepresented program incentive and fundamental entitlement initiative for welfare reform

This systemic concept on providing the similar situated recipient with relevant rehabilitation services needs to be represented by our District legislators

Within the correspondence issued by agency misinformation standards I am the subject of this static agency official non-compliance

The critical program information on the agency funding empowerment recommendations in job placement assistance which I reported is being devalued by our academic leaders

Other similar situated disabled recipients reportedly receive this identical form of public disservice

Money is likely transferred to accommodate some other unknown government business agenda

The pre-assigned agency official withdrew my individualized request for market assistance in economic development upon filing my Intellectual Property certification and a registered trademark

This professional malpractice performance issue on culture civil rights is further caused myself undue post-traumatic-stress

This unorganized state DPHHS program management structure agenda needs reform

It is by my individual experience with meeting adversary organization interests on objective rehabilitation benefits that I find this state government office is been commercially fraudulent with its obligation to provide me public assistance benefits to restore the damages done in my public education, health and welfare poverty status

When I proposed my conservative rehabilitation business plan on the education program utilization of basic literary tools provided to accommodate diverse individual commercial production interests

Appointed representatives on my behalf were argumentative and did not hesitate to handicap my individualized requests for subsidies to license and market my revolutionary pilot project program

The context with my repetitive request for education assistance is to develop my rehabilitation commercial byproduct concept on community economic development

These negative insults with confrontation conducted by the agency daily behavior is unconstitutional in nature

On behalf of reports that I provided to empower my marketplace expressions

I ask that you take this educational and economic program initiative on culture investment and thoroughly modify and modernize these inefficient administration tables of deceptive practice

The appointed rehabilitation agent's work ethic skill is undisciplined on behalf of the tax payer return-on-investment interest

The unregulated behavior of assigned agents threaten outside culture rights upon our due process of law

The evidence upon personal issues in individualized rehabilitation is ceremoniously outsourced

The information on my investment character is being disenfranchised by assigned agent's spontaneous behavior

I have worked many hours and produced relevant commercial information for job placement assistance but have not yet been adequately compensated by this irrational government office

My Constitutional Freedoms are greatly damaged by this commercial injustice

The professional information that I had reported within aptitude tests and scores and the proposal for market assistance with Intellectual Property that I produced are equally plagiarized upon

I am further authorized and register my complaint with the 2005 Health & Human Services Appropriations Subcommittee upon the agency non-disclosure of relevant rehabilitation-technology program benefits administered to remedy my controversial individual "identity crisis" situation

The agency has falsified its economic reports and compromised in sponsoring my reinstatement

This government program opposition to adequately subsidize the economic incentive issues with my private rehabilitation welfare reform program initiative is inhumane and unconstitutional in nature

The timely requests that I made for their reconsideration on providing me with irrelevant alternative technology benefits made no direct difference

My case would again be either prematurely closed or it was shuffled to a new pre-assigned agent who had similar disinterests on serving my economic right

The exploitation by academic leaders is inefficient in nature

These agency appointees neglected to incorporate my market skill

I further ask you that a legislation bill be drafted on my behalf to repeal the government formation of these adverse rehabilitation program management obstacles

A complimentary amendment on these diverse public relations matters should follow

I'm further offended because I don't have any individual voice on the form of assessment that is provided by agents to market my commercial expression goals

I report to you with publication on the association to my negative experience that the lawless antisocial behavior that is been ceremoniously conducted by this public relations entity should be held accountable to fully compensate and subsidize the environmental research and development qualities with synergism upon my innovative economic development pilot project

I am adversely being discriminated against by this agency policy that dictates the disclosure of irrelevant resources administered in individual job placement proceedings

This unsupervised Montana Department needs to be re-regulated

In response to suffering by this official negligence

My rights in industry production are officially handicapped

I am the subject of reprisal by this government organization's intimidation, harassment and humiliation...

The environmental principles that I have worked long hours to provide upon empowerment and building my dignity, integrity and self-esteem is been ceremoniously altered

The agencies conformation standard to public conformity is detrimental in nature

This form of government official inaction with procedures on culture expression related entitlement issues further help justify my providing a rehabilitation program source to reform the administration disincentives on culture production rights

I am further discriminated against when the pre-approved officials with the Montana Advocacy Program also decline to provide me with their advocacy service to represent my revolutionary civil rights agenda

This federally funded state agency needs to be severely disciplined also

While these agents build their own living standard and material comfort they improvise upon building their applicant's economic freedom

I further my rehabilitation program clarification initiative on accountability by providing the audited Department agency official with re-assignment and/or replacement

The valuable information with rehabilitation market trade secrets that I produced is a valuable source for domestic tranquility

Similar to the negative response with apathy received from the State on my Supreme Court appeal

They, too, have been conscientiously unable to discern my innovative rehabilitation grammar assessment skill for culture investment

My ingenuity and perspective on giving this societies under served culture a decisive and more supporting individual value judgment is taken out-of-context

The current DPHHS agency management structure remains inarticulate and fails to construct a reputable Welfare State reform program to work in my advantage

However, this injurious phenomenon with public official inaction remains treatable

I am currently oppressed and left unnecessarily dependent

It's within my grassroots perception on progressive rehabilitation service that I state that our tax base is also being equally misrepresented by this inefficient agency performance

History is repeating itself without our Montana public having a legislature audit on these deceptive internal money management standards

I am a under served symbol to reform this state agencies apathetic and unpatriotic performance

I therefore ask that you keep me informed on the status of my diverse request for legislative assistance
