## You Can Legally Avoid Seat Belt Tickets If You Qualify for a Medical Exemption!

### Do You Experience Discomfort Or Pain When Wearing Your Seat belt?

**All of the 49 states with seat belt laws have medical exemptions to wearing seatbelts.** For example, Washington's seat belt law states: *"This section does not apply to an operator or passenger who possesses written verification from a licensed physician that the operator or passenger is unable to wear a safety belt for physical or medical reasons."*

**We offer a medical evaluation in the form of a Medical History Questionnaire designed to detect medical reasons for your pain or discomfort, which will be evaluated by a licensed physician.** If the evaluation results in a diagnosis exempting you from using a seat belt, for a \$39.00 medical evaluation fee, written verification in the form of a letter and prescription form will be mailed by our licensed physician. This letter, or the prescription form, when shown to a law officer will prevent an otherwise costly citation.

**Don't put up with pain when wearing your seatbelt! Just fill out the 18 Yes/No questions in the Medical History Questionnaire.**  
**If you qualify, for a \$39.00 medical evaluation fee, the doctor will evaluate your questionnaire and mail you your medical exemption.**

**To quickly see if you might qualify, please fill out the Medical History Questionnaire. You will be immediately provided with a preliminary diagnosis. Then indicate the form of payment (VISA, MasterCard, or PayPal) you wish to use for the \$39.00 medical evaluation fee (a fee is charged only if the doctor determines that you qualify).**

The doctor will evaluate your questionnaire and if you qualify, the exemption letter and prescription form will be sent to your address in about a week.


