We are opposed to the HB583 for the following reasons.

The narrow scope of the "domicile aspect" of the bill is defined without an understanding of the car rental industry. The mobility of a vehicle is what separates us from the accommodations industry. We do not have a domicile for a vehicle in that the vehicle is moved to accommodate customer reservations on an "as needed" basis, thus the vehicle control is regulated by the demand of each market.

We have 10 offices in 7 counties operating between 10 and 250 cars and at varying times. Not only would managing such domicile records be extremely difficult, I would think it would be nearly impossible to police it from the states' perspective.

The definition applied to the word "domicile" is vague as the locations where the vehicle is used has little to do with where it is controlled or dispatched from and of course vice-versa. There are 26 car classes and 3 reservations systems, thus we would have to account for the movement of 78 car classes for 10 locations in 7 counties. I hope the committee understands our perspective on this bill.
