Insert: "COORDINATION SECTION. Section 2. Coordination instruction. If Senate Bill No. 285 and [this act] are both passed and approved, then 61-3-704 must be amended as follows:

"61-3-704. Penalty. (1) Any person operating a motor vehicle, trailer, semitrailer, or pole trailer in violation of the intent and purpose of 61-3-701 or 61-3-702 shall be is guilty of a misdemeanor and upon conviction of this offense shall be punished by a fine of \$300.

(2) Any person operating a motor vehicle, trailer, semitrailer, or pole trailer in violation of 61-3-702 is guilty of a misdemeanor and upon conviction thereof of this offense shall be punished by a fine of not less than \$10 or more than \$50, or confined in the county jail for not more than 30 days, or both such fine and imprisonment."
