

To the Senate Judiciary Committee Honorable Members,

The reason we are in a hearing to discuss SB 199 - the inclusion of sexual orientation in human rights and other laws has to do with the agenda of the homosexual movement. The homosexual propaganda machine is based on Hitler's 'Big Lie' technique.

First of all I am against the word "sexual orientation" because it is not defined. It opens the door to pedophilia, incest, bigamy, multiple partners, bestiality, and etc. I believe this is what homosexuals want if you take into account their agenda as a whole.

The "human rights and other law" is included to make themselves look like victims and to punish those who strive to attain moral standards. Eric Pollard, a founder of ACT UP/D.C., says that ACT/UP's philosophy was built upon the writings of Hitler in Mein Kampf. In the Washington Blade on January 31, 1991, Pollard has admitted to using Hitler's propaganda and Nazi Brown Shirt strategies to terrorize opponents of homosexual activism.

Homosexuals have made their propaganda strategies clear in two major documents: "the Overhauling of Straight America" published in Guide Magazine, November 1987. The expanded version of this article is called "After the Ball: How America will conquer its fear & hatred of Gays in the 90's. The writer of this article, Marshall K. Kirk, and Erastes Pill lay out a program of deceit and vilification. It includes the following:

1. Talk about gays and gayness as loudly and as often as possible.

'Using Hollywood as means, the objective is to desensitize the public to its revulsion ... in a supportive manner.' Kirk and Pill write, "It is essential to undermine the moral authority of churches who oppose homosexuality by "muddying the moral waters, ... and by "portraying conservative churches as 'homophobic.'" It went on to mention they should not shock and repel the public by talking about their deviant sexual behaviors. These behaviors include anal intercourse, oral sex, rimming - the practice of licking the anus which result in intestinal diseases; Golden showers - urinating on one's partner, sexual orgies involving several men; anonymous sex using "glory holes" in sex clubs, fisting - the act of shoving ones fist and arm up the anus of a partner; sadomasochism - cuttings and beatings, drug usage including amphetamines to enhance sexual pleasure, and bareback parties involving several men. These men may be HIV infected but do not use condoms. In many circles, getting aids now has become a badge of honor.

2. Portray gays as victims, not as aggressive challengers

This goal is to be accomplished by portraying homosexuals as "victims of fate" in which they had no choice. Only normal looking homosexuals are to be shown in media efforts. They are to be portrayed as "victims" of society by being portrayed as brutalized, and victims of housing and job discrimination, and victims of public humiliation. Homosexuals are to avoid demanding "direct support for homosexual practices, but should instead take anti-discrimination as its theme. Avoid discussion of homosexual behaviors, but concentrate on free speech, freedom of beliefs and association.

3. Make gays look good. Homosexuals should be portrayed as "Everyman" but actually morally superior to heterosexuals. Kirk and Pill urge the use of celebrity endorsements. "In no time a skillful and clever media campaign could have the gay community looking like the veritable fairy godmother to Western Civilization."

4. Make the victimizers look bad. According to Kirk and Pill, the opponents of homosexuality should be linked to images of the KKK and Nazis. "The public should be shown images of ranting homophobes whose traits disgust Middle America. These images might include: the KKK demanding that gays be burned alive or castrated; bigoted southern ministers drooling with hysterical hatred to a degree that it looks both comical and deranged; menacing punks, thugs, and convicts speaking coolly about the 'fags' they killed or would like to kill.

While the Matthew Shephard incident is still being talked about, the same propaganda machine has minimized and discounted the brutal torture murder of 13-year-old Jesse Dirkhising who was killed by two homosexual men in Arkansas. He was repeatedly sodomized by Josh Brown, while Brown's lover looked on. This story was virtually ignored by mainstream media. This is not an isolated case. In the world of homosexuality, homosexuals can only be victims, never perpetrators of hatred or murder.

5. "Jamming" In *After the Ball: How America will conquer its fear & hatred of Gays in the 90s*, authors Marshall Kirk and Hunter point out that this is a psychological brainwashing technique that involves Associative Conditioning and Direct Emotional Modeling. The person being brainwashed is to be bombarded with images of homosexuals being persecuted, discriminated against or murdered. As he is subjected to these images, he develops a sense of shame. In DEM, he is to be shown that he is in the minority and are to be shunned by others. "... To desensitize straights to gays and gayness, inundate them in a continuous flood of gay-related advertising, presented in the least offensive fashion possible. If straights can't shut off the shower, they may at least eventually get used to being wet. Of course, while sheer indifference is, itself, vastly preferable to hatred and threats, we would like to do better than that."

6. "Conversion" The authors mean conversion of the average American's emotions, mind, and will, through planned psychological attack fed to the nation via media.

7. Censoring the Opposition. One of the primary efforts of homosexuals is to prevent truth from being known. Through mainstream media outlets, GLAAD and other groups have been successful in convincing journalists to shy away from any stories that might portray gays in any negative way.

In my search for truth, I believe homosexuals have victimized themselves making SB 199 redundant. I am against this bill. Thank you for your consideration.
