

## HOUSE BILL NO. 48

INTRODUCED BY H. JACOBSON

BY REQUEST OF THE DEPARTMENT OF MILITARY AFFAIRS

A BILL FOR AN ACT ENTITLED: "AN ACT AUTHORIZING THE DEPARTMENT OF MILITARY AFFAIRS TO ESTABLISH THE NATIONAL GUARD EDUCATION BENEFIT PROGRAM; EXTENDING THE TERMINATION DATE FOR TUITION WAIVERS FOR A QUALIFIED MEMBER OF THE MONTANA NATIONAL GUARD; AMENDING SECTION 20-25-421, MCA, AND SECTION 5, CHAPTER 577, LAWS OF 2005; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

**Section 1.** Section 20-25-421, MCA, is amended to read:

**"20-25-421. (Temporary) Charges for tuition -- waivers.** (1) The regents may prescribe tuition rates, matriculation charges, and incidental fees for students in institutions under their jurisdiction.

(2) The regents may:

(a) waive nonresident tuition for selected and approved nonresident students, not to exceed at any unit 2% of the full-time equivalent enrollment at that unit during the preceding year; however, when necessary, tuition may be waived in excess of 2% of unit enrollment for nonresident students who enroll under provisions of any WICHE-sponsored state reciprocal agreements that provide for the payment, when required, of the student support fee by the reciprocal state;

(b) waive resident tuition for students at least 62 years of age;

(c) waive tuition and fees for:

(i) persons of one-fourth Indian blood or more who have been bona fide residents of Montana for at least 1 year prior to enrollment in the Montana university system;

(ii) persons designated by the department of corrections pursuant to 52-5-112 or 53-1-214;

(iii) residents of Montana who served with the armed forces of the United States in any of its wars and who were honorably discharged from military service;

(iv) children of residents of Montana who served with the armed forces of the United States in any of its wars and who were killed in action or died as a result of injury, disease, or other disability incurred while in the

2 (v) the spouses or children of residents of Montana who have been declared to be prisoners of war or  
3 missing in action; or

4 (vi) the spouse or children of a Montana national guard member who was killed or died as a result of  
5 injury, disease, or other disability incurred in the line of duty while serving on state active duty;

6 (d) waive tuition charges for qualified survivors of Montana firefighters or peace officers killed in the  
7 course and scope of employment. For purposes of this subsection, a qualified survivor is a person who meets  
8 the entrance requirements at the state university or college of the person's choice and is the surviving spouse  
9 or child of any of the following who were killed in the course and scope of employment:

10 (i) a paid or volunteer member of a municipal or rural fire department;

11 (ii) a law enforcement officer as defined in 7-32-201; or

12 (iii) a full-time highway patrol officer.

13 (e) waive tuition for up to 5,000 credits each academic year in accordance with the Montana national  
14 guard education benefit program ~~established by, which~~ the department of military affairs is authorized to establish.

15 The waivers provided for in this subsection (2)(e) are intended to be available for up to 5 years after the person  
16 qualifies. (Terminates June 30, 2009--~~sec. 5, Ch. 577, L. 2005~~ 2011.)

17 **20-25-421. (Effective July 1, 2009 2011) Charges for tuition -- waivers.** (1) The regents may prescribe  
18 tuition rates, matriculation charges, and incidental fees for students in institutions under their jurisdiction.

19 (2) The regents may:

20 (a) waive nonresident tuition for selected and approved nonresident students, not to exceed at any unit  
21 2% of the full-time equivalent enrollment at that unit during the preceding year; however, when necessary, tuition  
22 may be waived in excess of 2% of unit enrollment for nonresident students who enroll under provisions of any  
23 WICHE-sponsored state reciprocal agreements that provide for the payment, when required, of the student  
24 support fee by the reciprocal state;

25 (b) waive resident tuition for students at least 62 years of age;

26 (c) waive tuition and fees for:

27 (i) persons of one-fourth Indian blood or more who have been bona fide residents of Montana for at least  
28 1 year prior to enrollment in the Montana university system;

29 (ii) persons designated by the department of corrections pursuant to 52-5-112 or 53-1-214;

30 (iii) residents of Montana who served with the armed forces of the United States in any of its wars and

1 who were honorably discharged from military service;

2 (iv) children of residents of Montana who served with the armed forces of the United States in any of its  
3 wars and who were killed in action or died as a result of injury, disease, or other disability incurred while in the  
4 service of the armed forces of the United States;

5 (v) the spouses or children of residents of Montana who have been declared to be prisoners of war or  
6 missing in action; or

7 (vi) the spouse or children of a Montana national guard member who was killed or died as a result of  
8 injury, disease, or other disability incurred in the line of duty while serving on state active duty;

9 (d) waive tuition charges for qualified survivors of Montana firefighters or peace officers killed in the  
10 course and scope of employment. For purposes of this subsection, a qualified survivor is a person who meets  
11 the entrance requirements at the state university or college of the person's choice and is the surviving spouse  
12 or child of any of the following who were killed in the course and scope of employment:

13 (i) a paid or volunteer member of a municipal or rural fire department;

14 (ii) a law enforcement officer as defined in 7-32-201; or

15 (iii) a full-time highway patrol officer.

16 (3) If funds are available after the waivers provided for in subsection (2), the regents may waive tuition  
17 for up to 5,000 credits each academic year ~~in accordance with the Montana national guard education benefit~~  
18 ~~program provided for in 10-1-121], which the department of military affairs is authorized to establish."~~

20 **Section 2.** Section 5, Chapter 577, Laws of 2005, is amended to read:

21 **"Section 5. Termination.** [This act] terminates June 30, ~~2009~~ 2011."

23 NEW SECTION. **Section 3. Effective date.** [This act] is effective on passage and approval.
