12	WHEREAS, wolves are having an intolerable impact on hunting opportunities in Montana in conflict with
13	Article IX, section 7, of the Montana Constitution and section 87-1-217, MCA, as well as a deleterious impact on
14	livestock; and
15	WHEREAS, since 2000, agents of the federal government have repeatedly intimated to the public that
16	wolves would be imminently removed from the endangered species list, but delisting remains to be accomplished;
17	and
18	WHEREAS, Friends of the Northern Yellowstone Elk Herd is a Montana public interest membership
19	organization that has preserved the prerogative to sue in federal court over wolf delisting by following the
20	administrative law of the federal Endangered Species Act of 1973; and
21	WHEREAS, the Budd-Falen law firm of Cheyenne, Wyoming, is counsel for the lawsuit filed by Friends
22	of the Northern Yellowstone Elk Herd in its effort to challenge the failure of the federal government to remove
23	wolves from the endangered species list; and
24	WHEREAS, participation in this <u>PENDING</u> lawsuit by the State of Montana would benefit Montana citizens
25	and effectuate Article IX, section 7, of the Montana Constitution and section 87-1-217, MCA.

27	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

29	NEW SECTION. Section 1. Appropriation. There is appropriated \$200,000 from the general fund to

1	of the northern Yellowstone elk herd challenging the failure of the federal government to remove wolves from the
2	endangered species list. A total of up to \$150,000 may be used for contract legal services, and up to \$50,000 may
3	be used by the legislative services division for management and administrative expenses.
