| 10 | Section 1. Section 61-8-359, MCA, is amended to read: |
| 11 | "61-8-359. Riding on motorcycles. (1) A person operating a motorcycle or quadricycle on public streets |
| 12 | or highways may ride only upon the permanent and regular seat attached to the motorcycle or quadricycle. The |
| 13 | operator may not carry any other person and another person may not ride on a motorcycle or quadricycle unless |
| 14 | the motorcycle or quadricycle is designed to carry more than one person, in which event a passenger may ride |
| 15 | upon the permanent and regular seat if designed for two persons or upon another seat firmly attached to the rear |
| 16 | or side of the operator. |
| 17 | (2) A passenger may not be carried in a position that will interfere with the operation of the motorcycle |
| 18 | or quadricycle or the view of the operator. |
| 19 | (3) A person operating a motorcycle or quadricycle may not carry any packages, bundles, or articles that |
| 20 | would prevent the operator from keeping both hands on the handlebars or that would interfere with the operation |
| 21 | of the vehicle in a safe and prudent manner. |
| 22 | (4) A person may ride upon a motorcycle or quadricycle only while sitting astride the seat, facing forward, |
| 23 | with one leg on each side of the motorcycle or quadricycle. |
| 24 | (5) Except as provided in subsections (5)(a) and (5)(b), motorcycles and quadricycles must be operated |
| 25 | with lights on at all times when operated on any public roadway. A motorcycle or quadricycle may be operated |
| 26 | without lights from one-half hour before sunrise to one-half hour after sunset if: |
| 27 | (a) the motorcycle is registered under 61-3-411 as a collector's item and if persons and vehicles are |
| 28 | clearly discernible at a distance of 500 feet; or |
| 29 | (b) the motorcycle or quadricycle is being driven to the nearest repair facility for headlamp repair. |
| 30 | (6) A person operating a motorcycle or quadricycle on the public streets or highways and any passenger |

1 riding on a motorcycle or quadricycle on the public streets or highways shall wear a properly attached motorcycle 2 helmet at all times. 3 (6)(7) No more than two motorcycles may be operated side by side in a single traffic lane. 4 (7)(8) All motor vehicles, including motorcycles and quadricycles, are entitled to the full use of a traffic 5 lane, and a vehicle may not be driven or operated in a manner that deprives any other vehicle of the full use of 6 a traffic lane, except that motorcycles may, with the consent of both drivers, be operated no more than two 7 abreast in a single traffic lane. 8 (8) (9) Every person riding a motorcycle or quadricycle upon a roadway is granted all of the rights and 9 is subject to all of the duties applicable to the driver of a motor vehicle except for those provisions which, by their 10 nature, can have no application. 11 (10) A peace officer may require a person who is violating subsection (6) to stop the motorcycle or 12 quadricycle even if the person is not violating any other traffic violation and even if the motorcycle or quadricycle 13 is safe and equipped as required by law.
