18 NEW SECTION. Section 1. State ethics commission. (1) There is a state ethics commission that 19 consists of four members. One member must be appointed by the president of the senate, one by the minority 20 leader of the senate, one by the speaker of the house, and one by the minority leader of the house. The 21 members of the commission shall elect a presiding officer from among the members. A member of the 22 commission may not be a public officer or an employee of the state or a political subdivision of the state or the 23 spouse or child of a public officer or an employee of the state or a political subdivision of the state. Members shall 24 serve staggered 4-year terms and may not be reappointed to a succeeding term. A vacancy on the commission 25 must be filled by an appointment by the appropriate appointing authority that appointed the vacating 26 commissioner.

(2) The state ethics commission is attached to the office of the secretary of state for administrative
purposes only, as specified in 2-15-121, except that the provisions of 2-15-121(1)(b), (1)(c), (2)(a), (2)(b), (2)(d),
(2)(e), and (3)(a) do not apply. Members of the state ethics commission are entitled to be paid \$50 for each day
in which the member is actually and necessarily engaged in the performance of commission duties and are also



entitled to be reimbursed for travel expenses, as provided for in 2-18-501 through 2-18-503, incurred while in the 1 2 performance of commission duties. 3 (3) The state ethics commission shall employ an executive director and may employ an attorney and 4 administrative staff, as necessary. The state ethics commission may delegate authority to the executive director 5 to act in the name of the state ethics commission between meetings. 6 7 NEW SECTION. Section 2. State ethics commission functions. (1) The state ethics commission has 8 the functions prescribed in Title 2, chapter 2, in Title 5, chapter 7, and in Title 13, chapters 27, 35, and 37. The 9 state ethics commission may investigate complaints, conduct contested case hearings under Title 2, chapter 4, 10 part 6, develop policies, adopt rules, and enforce laws within the commission's jurisdiction. 11 (2) The state ethics commission shall review the recommendations of the executive director and may 12 accept, revise, or overturn a recommendation. 13 (3) The state ethics commission may conduct ethics training for legislators, state officers, state 14 employees, local government officials, and local government employees. 15 16 Section 3. advertisement or public service announcement in a newspaper, on radio, or on television that contains the
candidate's name, picture, or voice except in the case of a state or national emergency and then only if the
announcement is reasonably necessary to the candidate's official functions.

(5) A public officer or public employee may not participate in a proceeding when an organization, other
 than an organization or association of local government officials, of which the public officer or public employee
 is an officer or director is:

(a) involved in a proceeding before the employing agency that is within the scope of the public officer's
or public employee's job duties; or

(b) attempting to influence a local, state, or federal proceeding in which the public officer or publicemployee represents the state or local government.

(6) A public officer or public employee may not engage in any activity, including lobbying, as defined in
 5-7-102, on behalf of an organization, other than an organization or association of local government officials, of

which the public officer or public employee is a member while performing the public officer's or public employee's
 job duties. The provisions of this subsection do not prohibit a public officer or public employee from performing
