4	A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF		
5	MONTANA REQUESTING A LEGISLATIVE INTERIM STUDY OF CAMPAIGN FINANCE LAWS AND A REPORT		
6	TO THE 61ST LEGISLATURE.

8	WHEREAS, Montanans expect clean and fair elections and are concerned about the rapidly escalating		
9	amount of money required to run for elective office in Montana; and		
10	WHEREAS, the League of Women Voters of the United States reports that a better elections system		
11	called "Clean Elections", is already in place in seven states and two municipalities and that this is a proved way		
12	to improve campaign financing; and		
13	WHEREAS, under a Clean Elections system, eligible candidates receive a grant of public money for their		
14	campaigns so that qualified people who would otherwise not run for election can run competitive campaigns or		
15	level playing fields; and		
16	WHEREAS, Clean Elections would likely encourage more participation in elections in Montana; and		
17	WHEREAS, an interim study would provide for a much needed comprehensive review of Montana's		
18	campaign finance laws; and		
19	WHEREAS, an interim study provides a forum for healthy bipartisan debate among legislators		
20	stakeholders, and the general public about how best to approach campaign financing reforms.

22	NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE		
23	STATE OF MONTANA:		
24	That the Legislative Council be requested to designate an appropriate interim committee, pursuant to		
25	section 5-5-217, MCA, or direct sufficient staff resources to:		
26	(1) review Montana's current campaign finance laws;		
27	(2) examine campaign finance reform, including clean election laws adopted in other jurisdictions; and		
28	(3) investigate and analyze options for public financing of campaigns.		
29	BE IT FURTHER RESOLVED, that the appropriate interim committee or sufficient staff resources be		
30	directed to develop recommendations for campaign finance reform and publically financed campaigns in
