4 A BILL FOR AN ACT ENTITLED: "AN ACT AMENDING SEXUAL OFFENSE PENALTIES TO SUBSTANTIALLY  
5 ADOPT THE PENALTIES PROVIDED IN FLORIDA'S JESSICA LUNSFORD ACT; PROVIDING FOR  
6 PENALTIES OF 25 YEARS TO LIFE IMPRISONMENT AND FOR SENTENCE ENHANCEMENT FOR USE OF  
7 THE INTERNET IN THE COMMISSION OF CERTAIN SEXUAL OFFENSES; PROVIDING FOR LIFETIME  
8 PROBATION FOR OFFENDERS NOT SENTENCED TO LIFE IMPRISONMENT; PROVIDING FOR MONETARY  
9 FINES; AMENDING SECTIONS 45-5-502, 45-5-503, 45-5-504, 45-5-505, 45-5-507, 45-5-512, 45-5-622,  
10 45-5-625, 45-5-627, 46-1-202, 46-16-216, 46-18-201, 46-18-205, 46-18-219, 46-18-222, 46-18-231, 46-23-201,  
11 AND 46-23-1011, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

15 **Section 1.** Section 45-5-502, MCA, is amended to read:

16 **"45-5-502. Sexual assault.** (1) A person who knowingly subjects another person to any sexual contact  
17 without consent commits the offense of sexual assault.

18 (2) ~~A~~ Except as provided in subsection (4), a person convicted of sexual assault shall be fined an amount  
19 not to exceed \$500 or be imprisoned in the county jail for a term not to exceed 6 months, or both.

20 (3) ~~if~~ Except as provided in subsection (4), if the victim is less than 16 years old of age and the offender  
21 is 3 or more years older than the victim or if the offender inflicts bodily injury upon anyone in the course of  
22 committing sexual assault, the offender shall be punished by life imprisonment or by imprisonment in the state  
23 prison for a term of not less than 4 years, unless the judge makes a written finding that there is good cause to  
24 impose a term of less than 4 years and imposes a term of less than 4 years, or more than 100 years and may  
25 be fined an amount not more than \$50,000.

26 (4) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
27 offender is 18 years of age or older, the offender shall be punished by:

28 (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

29 (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

30 and



1 (c) a fine of at least \$25,000 and not more than \$50,000.

2 ~~(4)(5)~~ An act "in the course of committing sexual assault" includes an attempt to commit the offense or  
3 flight after the attempt or commission.

4 ~~(5)(6)~~ Consent is ineffective under this section if:

5 (a) the victim is incarcerated in an adult or juvenile correctional, detention, or treatment facility and the  
6 perpetrator is an employee, contractor, or volunteer of the facility and has supervisory or disciplinary authority  
7 over the victim, unless the act is part of a lawful search; or

8 (b) the victim is less than 14 years ~~old~~ of age and the offender is 3 or more years older than the victim.

9 (7) Consent is ineffective under subsection (4)."

10

11 **Section 2.** Section 45-5-503, MCA, is amended to read:

12 **"45-5-503. Sexual intercourse without consent.** (1) A person who knowingly has sexual intercourse  
13 without consent with another person commits the offense of sexual intercourse without consent. A person may  
14 not be convicted under this section based on the age of the person's spouse, as provided in 45-5-501(1)(b)(iv).

15 (2) A person convicted of sexual intercourse without consent shall be punished by life imprisonment or  
16 by imprisonment in the state prison for a term of not less than 2 years or more than 100 years and may be fined  
17 not more than \$50,000, except as provided in 46-18-219 and 46-18-222.

18 (3) (a) ~~If~~ Except as provided in subsection (4), if the victim is less than 16 years ~~old~~ of age and the  
19 offender is 3 or more years older than the victim or if the offender inflicts bodily injury upon anyone in the course  
20 of committing sexual intercourse without consent, the offender shall be punished by life imprisonment or by  
21 imprisonment in the state prison for a term of not less than 4 years or more than 100 years and may be fined not  
22 more than \$50,000, except as provided in 46-18-219 and 46-18-222.

23 (b) If two or more persons are convicted of sexual intercourse without consent with the same victim in  
24 an incident in which each offender was present at the location where another offender's offense occurred during  
25 a time period in which each offender could have reasonably known of the other's offense, each offender shall be  
26 punished by life imprisonment or by imprisonment in the state prison for a term of not less than 5 years or more  
27 than 100 years and may be fined not more than \$50,000, except as provided in 46-18-219 and 46-18-222.

28 (c) If the offender was previously convicted of an offense under this section or of an offense under the  
29 laws of another state or of the United States that if committed in this state would be an offense under this section  
30 and if the offender inflicted serious bodily injury upon a person in the course of committing each offense, the

1 offender shall be:

2 (i) punished by death as provided in 46-18-301 through 46-18-310, unless the offender is less than 18  
3 years of age at the time of the commission of the offense; or

4 (ii) punished as provided in 46-18-219.

5 (d) If the victim was incarcerated in an adult or juvenile correctional, detention, or treatment facility at the  
6 time of the offense and the offender had supervisory or disciplinary authority over the victim, the offender shall  
7 be punished by imprisonment in the state prison for a term of not more than 5 years or fined an amount not to  
8 exceed \$50,000, or both.

9 (4) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
10 offender is 18 years of age or older, the offender shall be punished by:

11 (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

12 (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

13 and

14 (c) a fine of at least \$25,000 and not more than \$50,000.

15 ~~(4)~~(5) In addition to any sentence imposed under subsection (2), ~~(3)~~, or ~~(3)~~ (4), after determining the  
16 financial resources and future ability of the offender to pay restitution as required by 46-18-242, the court shall  
17 require the offender, if able, to pay the victim's reasonable medical and counseling costs that result from the  
18 offense. The amount, method, and time of payment must be determined in the same manner as provided for in  
19 46-18-244.

20 ~~(5)~~(6) As used in subsection (3), an act "in the course of committing sexual intercourse without consent"  
21 includes an attempt to commit the offense or flight after the attempt or commission."

23 **Section 3.** Section 45-5-504, MCA, is amended to read:

24 **"45-5-504. Indecent exposure.** (1) A person commits the offense of indecent exposure if the person  
25 knowingly or purposely exposes the person's genitals under circumstances in which the person knows the  
26 conduct is likely to cause affront or alarm in order to:

27 (a) abuse, humiliate, harass, or degrade another; or

28 (b) arouse or gratify the person's own sexual response or desire or the sexual response or desire of any  
29 person.

30 (2) (a) ~~A~~ Except as provided in subsection (3), a person convicted of the offense of indecent exposure

1 shall be fined an amount not to exceed \$500 or be imprisoned in the county jail for a term of not more than 6  
2 months, or both.

3 (b) ~~On~~ Except as provided in subsection (3), on a second conviction, the person shall be fined an amount  
4 not to exceed \$1,000 or be imprisoned in the county jail for a term of not more than 1 year, or both.

5 (c) ~~On~~ Except as provided in subsection (3), on a third or subsequent conviction, the person shall be  
6 punished by life imprisonment or by imprisonment in a state prison for a term of not less than 5 years or more  
7 than 100 years and may be fined not more than \$10,000.

8 (3) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
9 offender is 18 years of age or older, the offender shall be punished by:

10 (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

11 (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

12 and

13 (c) a fine of at least \$25,000 and not more than \$50,000."

15 **Section 4.** Section 45-5-505, MCA, is amended to read:

16 **"45-5-505. Deviate sexual conduct.** (1) A person who knowingly engages in deviate sexual relations  
17 or who causes another to engage in deviate sexual relations commits the offense of deviate sexual conduct.

18 (2) ~~A~~ Except as provided in subsection (4), a person convicted of the offense of deviate sexual conduct  
19 shall be imprisoned in the state prison for ~~any~~ a term not to exceed 10 years or be fined an amount not to exceed  
20 \$50,000, or both.

21 (3) The fact that a person seeks testing or receives treatment for the HIV-related virus or another  
22 sexually transmitted disease may not be used as a basis for a prosecution under this section and is not  
23 admissible in evidence in a prosecution under this section.

24 (4) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
25 offender is 18 years of age or older, the offender shall be punished by:

26 (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

27 (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

28 and

29 (c) a fine of at least \$25,000 and not more than \$50,000."

1           **Section 5.** Section 45-5-507, MCA, is amended to read:

2           **"45-5-507. Incest.** (1) A person commits the offense of incest if the person knowingly marries, cohabits  
3 with, has sexual intercourse with, or has sexual contact, as defined in 45-2-101, with an ancestor, a descendant,  
4 a brother or sister of the whole or half blood, or any stepson or stepdaughter. The relationships referred to in this  
5 subsection include blood relationships without regard to legitimacy, relationships of parent and child by adoption,  
6 and relationships involving a stepson or stepdaughter.

7           (2) Consent is a defense under this section to incest with or upon a stepson or stepdaughter, but consent  
8 is ineffective if the victim is less than 18 years ~~old~~ of age.

9           (3) ~~A~~ Except as provided in subsection (5), a person convicted of incest shall be punished by life  
10 imprisonment or by imprisonment in the state prison for a term not to exceed 100 years or be fined an amount  
11 not to exceed \$50,000.

12           (4) ~~If~~ Except as provided in subsection (5), if the victim is under 16 years of age and the offender is 3  
13 or more years older than the victim or if the offender inflicts bodily injury upon anyone in the course of committing  
14 incest, the offender shall be punished by life imprisonment or by imprisonment in the state prison for a term of  
15 not less than 4 years or more than 100 years and may be fined not more than \$50,000.

16           (5) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
17 offender is 18 years of age or older, the offender shall be punished by:

18           (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

19           (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

20 and

21           (c) a fine of at least \$25,000 and not more than \$50,000.

22           ~~(5)(6)~~ In addition to any sentence imposed under subsection (3), ~~(4)~~, or ~~(4)~~ (5), after determining the  
23 financial resources and future ability of the offender to pay restitution as required by 46-18-242, the court shall  
24 require the offender, if able, to pay the victim's reasonable costs of counseling that result from the offense. The  
25 amount, method, and time of payment must be determined in the same manner as provided for in 46-18-244."

26

27           **Section 6.** Section 45-5-512, MCA, is amended to read:

28           **"45-5-512. Chemical treatment of sex offenders.** (1) A person convicted of a first offense under  
29 45-5-502(3) or (4), 45-5-503(3) or (4), or 45-5-507(4) or (5) may, in addition to the sentence imposed under those  
30 sections, be sentenced to undergo medically safe medroxyprogesterone acetate treatment or its chemical

1 equivalent or other medically safe drug treatment that reduces sexual fantasies, sex drive, or both, administered  
2 by the department of corrections or its agent pursuant to subsection (4).

3 (2) A person convicted of a second or subsequent offense under 45-5-502(3) or (4), 45-5-503, or  
4 45-5-507 may, in addition to the sentence imposed under those sections, be sentenced to undergo medically safe  
5 medroxyprogesterone acetate treatment or its chemical equivalent or other medically safe drug treatment that  
6 reduces sexual fantasies, sex drive, or both, administered by the department of corrections or its agent pursuant  
7 to subsection (4).

8 (3) A person convicted of a first or subsequent offense under 45-5-502, 45-5-503, or 45-5-507 who is  
9 not sentenced to undergo medically safe medroxyprogesterone acetate treatment or its chemical equivalent or  
10 other medically safe drug treatment that reduces sexual fantasies, sex drive, or both, may voluntarily undergo  
11 such treatment, which must be administered by the department of corrections or its agent and paid for by the  
12 department of corrections.

13 (4) Treatment under subsection (1) or (2) must begin 1 week before release from confinement and must  
14 continue until the department of corrections determines that the treatment is no longer necessary. Failure to  
15 continue treatment as ordered by the department of corrections constitutes a criminal contempt of court for failure  
16 to comply with the sentence, for which the sentencing court shall impose a term of incarceration without possibility  
17 of parole of not less than 10 years or more than 100 years.

18 (5) Prior to chemical treatment under this section, the person must be fully medically informed of its  
19 effects.

20 (6) A state employee who is a professional medical person may not be compelled against the employee's  
21 wishes to administer chemical treatment under this section."

23 **Section 7.** Section 45-5-622, MCA, is amended to read:

24 **"45-5-622. Endangering welfare of children.** (1) A parent, guardian, or other person supervising the  
25 welfare of a child less than 18 years ~~old~~ of age commits the offense of endangering the welfare of children if the  
26 parent, guardian, or other person knowingly endangers the child's welfare by violating a duty of care, protection,  
27 or support.

28 (2) Except as provided in 16-6-305, a parent or guardian or any person who is 18 years of age or older,  
29 whether or not the parent, guardian, or other person is supervising the welfare of the child, commits the offense  
30 of endangering the welfare of children if the parent, guardian, or other person knowingly contributes to the

1 delinquency of a child less than:

2 (a) 18 years ~~old~~ of age by:

3 (i) supplying or encouraging the use of an intoxicating substance by the child; or

4 (ii) assisting, promoting, or encouraging the child to enter a place of prostitution; ~~or~~

5 (b) 16 years ~~old~~ of age by assisting, promoting, or encouraging the child to:

6 (i) abandon the child's place of residence without the consent of the child's parents or guardian; or

7 (ii) engage in sexual conduct; or

8 (c) 14 years of age by assisting, promoting, or encouraging the child to:

9 (i) abandon the child's place of residence without the consent of the child's parents or guardian; or

10 (ii) engage in sexual conduct.

11 (3) A parent, guardian, or other person supervising the welfare of a child less than 16 years of age may  
 12 verbally or in writing request a person who is 18 years of age or older and who has no legal right of supervision  
 13 or control over the child to stop contacting the child if the ~~requestor~~ requester believes that the contact is not in  
 14 the child's best interests. If the person continues to contact the child, the parent, guardian, or other person  
 15 supervising the welfare of the child may petition or the county attorney may upon the person's request petition  
 16 for an order of protection under Title 40, chapter 15. To the extent that they are consistent with this subsection,  
 17 the provisions of Title 40, chapter 15, apply. A person who purposely or knowingly violates an order of protection  
 18 commits the offense of endangering the welfare of children and upon conviction shall be sentenced as provided  
 19 in subsection (4).

20 (4) (a) A Except as provided in subsection (4)(b), a person convicted of endangering the welfare of  
 21 children shall be fined an amount not to exceed \$500 or be imprisoned in the county jail for ~~any~~ a term not to  
 22 exceed 6 months, or both. A person convicted of a second offense of endangering the welfare of children shall  
 23 be fined an amount not to exceed \$1,000 or be imprisoned in the county jail for ~~any~~ a term not to exceed 6  
 24 months, or both.

25 (b) Except as provided in [section 15] and 46-18-219, if the victim is less than 14 years of age and the  
 26 offender is 18 years of age or older, the offender shall be punished by:

27 (i) imprisonment in a state prison for a term of not less than 25 years and not more than life;

28 (ii) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

29 and

30 (iii) a fine of at least \$25,000 and not more than \$50,000.

1 (5) On the issue of whether there has been a violation of the duty of care, protection, and support, the  
2 following, in addition to all other admissible evidence, is admissible: cruel treatment; abuse; infliction of  
3 unnecessary and cruel punishment; abandonment; neglect; lack of proper medical care, clothing, shelter, and  
4 food; and evidence of past bodily injury.

5 (6) The court may order, in its discretion, any fine levied or any bond forfeited upon a charge of  
6 endangering the welfare of children paid to or for the benefit of the person or persons whose welfare the  
7 defendant has endangered."

9 **Section 8.** Section 45-5-625, MCA, is amended to read:

10 **"45-5-625. Sexual abuse of children.** (1) A person commits the offense of sexual abuse of children if  
11 the person:

12 (a) knowingly employs, uses, or permits the employment or use of a child in an exhibition of sexual  
13 conduct, actual or simulated;

14 (b) knowingly photographs, films, videotapes, develops or duplicates the photographs, films, or  
15 videotapes, or records a child engaging in sexual conduct, actual or simulated;

16 (c) knowingly, by any means of communication, including electronic communication as defined in  
17 45-8-213, persuades, entices, counsels, or procures a child under 16 years of age or a person the offender  
18 believes to be a child under 16 years of age to engage in sexual conduct, actual or simulated;

19 (d) knowingly processes, develops, prints, publishes, transports, distributes, sells, exhibits, or advertises  
20 any visual or print medium, including a medium by use of electronic communication, as defined in 45-8-213, in  
21 which a child is engaged in sexual conduct, actual or simulated;

22 (e) knowingly possesses any visual or print medium, including a medium by use of electronic  
23 communication, as defined in 45-8-213, in which a child is engaged in sexual conduct, actual or simulated;

24 (f) finances any of the activities described in subsections (1)(a) through (1)(d) and (1)(g), knowing that  
25 the activity is of the nature described in those subsections; or

26 (g) possesses with intent to sell any visual or print medium, including a medium by use of electronic  
27 communication, as defined in 45-8-213, in which a child is engaged in sexual conduct, actual or simulated.

28 (2) (a) ~~A~~ Except as provided in subsection (2)(d), a person convicted of the offense of sexual abuse of  
29 children shall be punished by life imprisonment or by imprisonment in the state prison for a term not to exceed  
30 100 years and may be fined not more than \$10,000.

1 (b) Except as provided in 46-18-219 and subsection (2)(d) of this section, if the victim is under 16 years  
 2 of age, a person convicted of the offense of sexual abuse of children shall be punished by life imprisonment or  
 3 by imprisonment in the state prison for a term of not less than 4 years or more than 100 years and may be fined  
 4 not more than \$10,000.

5 (c) Except as provided in 46-18-219 and subsection (2)(d) of this section, a person convicted of the  
 6 offense of sexual abuse of children for the possession of material, as provided in subsection (1)(e), shall be fined  
 7 an amount not to exceed \$10,000 or be imprisoned in the state prison for a term not to exceed 10 years, or both.

8 (d) Except as provided in [section 15] and 46-18-219, if the child involved in the exhibition, photograph,  
 9 film, videotape, recording, or other visual or audio medium is less than 14 years of age and the offender is 18  
 10 years of age or older, the offender shall be punished by:

11 (i) imprisonment in a state prison for a term of not less than 25 years and not more than life;

12 (ii) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

13 and

14 (iii) a fine of at least \$25,000 and not more than \$50,000.

15 (3) An offense is not committed under subsections (1)(d) through (1)(g) if the visual or print medium is  
 16 processed, developed, printed, published, transported, distributed, sold, possessed, or possessed with intent to  
 17 sell, or if the activity is financed, as part of a sex offender information or treatment course or program conducted  
 18 or approved by the department of corrections."

20 **Section 9.** Section 45-5-627, MCA, is amended to read:

21 **"45-5-627. Ritual abuse of minor -- exceptions -- penalty.** (1) ~~A~~ Except as provided in subsection (4),  
 22 a person commits the offense of ritual abuse of a minor if the person purposely or knowingly and as part of any  
 23 ceremony, rite, or ritual or of any training or practice for any ceremony, rite, or ritual:

24 (a) has sexual intercourse without consent with a person less than 16 years of age; commits assault,  
 25 aggravated assault, assault on a minor, or assault with a weapon against a victim less than 16 years of age; or  
 26 kills a person less than 16 years of age;

27 (b) actually or by simulation tortures, mutilates, or sacrifices an animal or person in the presence of the  
 28 minor;

29 (c) dissects, mutilates, or incinerates a human corpse or remains in the presence of the minor;

30 (d) forces upon the minor or upon another person in the presence of a minor the ingestion or the external

1 bodily application of human or animal urine, feces, flesh, blood, bone, or bodily secretions or drugs or chemical  
2 compounds;

3 (e) places a living minor or another living person in the presence of a minor in a coffin or open grave that  
4 is empty or that contains a human corpse or remains; or

5 (f) threatens the minor or, in the presence of the minor, threatens any person or animal with death or  
6 serious bodily harm and the minor reasonably believes that the threat will or may be carried out.

7 (2) This section does not apply to activities, practices, and procedures otherwise allowed by law.

8 (3) Except as provided in 46-18-219 and subsection (4) of this section, a person convicted of ritual abuse  
9 of a minor shall:

10 (a) for the first offense, be imprisoned in the state prison for a term of not less than 2 years or more than  
11 20 years and may be fined not more than \$50,000, or both; and

12 (b) for a second or subsequent offense, be imprisoned in the state prison for ~~any~~ a term of not less than  
13 2 years or more than 40 years and may be fined not more than \$50,000, or both.

14 (4) Except as provided in [section 15] and 46-18-219, if the victim of an act specified in subsection (1)  
15 is less than 14 years of age and the offender is 18 years of age or older, the offender shall be punished by:

16 (a) imprisonment in a state prison for a term of not less than 25 years and not more than life;

17 (b) probation for the rest of the offender's life if the offender is sentenced to less than life imprisonment;

18 and

19 (c) a fine of at least \$25,000 and not more than \$50,000.

20 ~~(4)~~(5) In addition to any sentence imposed under subsection (3) or (4), after determining pursuant to  
21 46-18-242 the financial resources and future ability of the offender to pay restitution, the court shall require the  
22 offender, if able, to pay the victim's reasonable costs of counseling that result from the offense. The amount,  
23 method, and time of payment must be determined in the same manner as provided for in 46-18-244."  
24

25 **Section 10.** Section 46-1-202, MCA, is amended to read:

26 **"46-1-202. Definitions.** As used in this title, unless the context requires otherwise, the following  
27 definitions apply:

28 (1) "Advanced practice registered nurse" means an individual certified as an advanced practice  
29 registered nurse provided for in 37-8-202, with a clinical specialty in psychiatric mental health nursing.

30 (2) "Arrestment" means the formal act of calling the defendant into open court to enter a plea answering

1 a charge.

2 (3) "Arrest" means taking a person into custody in the manner authorized by law.

3 (4) "Arrest warrant" means a written order from a court directed to a peace officer or to some other  
4 person specifically named commanding that officer or person to arrest another. The term includes the original  
5 warrant of arrest and a copy certified by the issuing court.

6 (5) "Bail" means the security given for the primary purpose of ensuring the presence of the defendant  
7 in a pending criminal proceeding.

8 (6) "Charge" means a written statement that accuses a person of the commission of an offense, that is  
9 presented to a court, and that is contained in a complaint, information, or indictment.

10 (7) "Conviction" means a judgment or sentence entered upon a guilty or nolo contendere plea or upon  
11 a verdict or finding of guilty rendered by a legally constituted jury or by a court of competent jurisdiction authorized  
12 to try the case without a jury.

13 (8) "Court" means a place where justice is judicially administered and includes the judge of the court.

14 (9) "Included offense" means an offense that:

15 (a) is established by proof of the same or less than all the facts required to establish the commission of  
16 the offense charged;

17 (b) consists of an attempt to commit the offense charged or to commit an offense otherwise included in  
18 the offense charged; or

19 (c) differs from the offense charged only in the respect that a less serious injury or risk to the same  
20 person, property, or public interest or a lesser kind of culpability suffices to establish its commission.

21 (10) "Judge" means a person who is vested by law with the power to perform judicial functions.

22 (11) "Judgment" means an adjudication by a court that the defendant is guilty or not guilty, and if the  
23 adjudication is that the defendant is guilty, it includes the sentence pronounced by the court.

 11 to pay the fine. In determining the amount and method of payment, the sentencing judge shall take into account  
 12 the nature of the crime committed, the financial resources of the offender, and the nature of the burden that  
 13 payment of the fine will impose.

14 (4) Any fine levied under this section in a felony case shall be in an amount fixed by the sentencing judge  
 15 not to exceed \$50,000."

17 **Section 19.** Section 46-23-201, MCA, is amended to read:

18 **"46-23-201. Prisoners eligible for nonmedical parole.** (1) Subject to the restrictions contained in  
 19 subsections (2) through ~~(5)~~ (6), the board may release on nonmedical parole by appropriate order any person  
 20 who is confined in a state prison or the state hospital or any person who is sentenced to the state prison and  
 21 confined in a prerelease center when in its opinion there is reasonable probability that the prisoner can be  
 22 released without detriment to the prisoner or to the community.

23 (2) Persons under sentence of death, persons sentenced to the department who have been placed by  
 24 the department in a state prison temporarily for assessment or sanctioning, and persons serving sentences  
 25 imposed under 46-18-202(2) or 46-18-219 may not be paroled.

26 (3) A prisoner serving a time sentence may not be paroled under this section until the prisoner has  
 27 served at least one-fourth of the prisoner's full term.

28 (4) A prisoner serving a life sentence may not be paroled under this section until the prisoner has served  
 29 30 years.

30 (5) A parole may be ordered under this section only for the best interests of society and not as an award

1 of clemency or a reduction of sentence or pardon. A prisoner may be placed on parole only when the board  
2 believes that the prisoner is able and willing to fulfill the obligations of a law-abiding citizen.

3 (6) An offender to whom [section 14] applies is not eligible for nonmedical parole.

5 **Section 20.** Section 46-23-1011, MCA, is amended to read:

6 **"46-23-1011. Supervision on probation.** (1) The department shall supervise probationers during their  
7 probation period, including the probationary period imposed pursuant to 45-5-502(4), 45-5-503(4), 45-5-504(3),  
8 45-5-505(4), 45-5-507(5), 45-5-622(4)(b), 45-5-625(2)(d), or 45-5-627(4), in accord with the conditions set by a  
9 sentencing judge. If the sentencing judge did not set conditions of probation at the time of sentencing, the court  
10 shall, at the request of the department, hold a hearing and set conditions of probation. The probationer must be  
11 present at the hearing. The probationer has the right to counsel as provided in chapter 8 of this title.

12 (2) A copy of the conditions of probation must be signed by the probationer. The department may require  
13 a probationer to waive extradition for the probationer's return to Montana.

14 (3) The probation and parole officer shall regularly advise and consult with the probationer to encourage  
15 the probationer to improve the probationer's condition and conduct and shall inform the probationer of the  
16 restoration of rights on successful completion of the sentence.

17 (4) (a) The probation and parole officer may recommend and a judge may modify or add any condition  
18 of probation or suspension of sentence at any time.

19 (b) The probation and parole officer shall provide the county attorney in the sentencing jurisdiction with  
20 a report that identifies the conditions of probation and the reason why the officer believes that the judge should  
21 modify or add the conditions.

22 (c) The county attorney may file a petition requesting that the court modify or add conditions as  
23 requested by the probation and parole officer.

24 (d) The court may grant the petition if the probationer does not object. If the probationer objects to the  
25 petition, the court ~~must~~ shall hold a hearing pursuant to the provisions of 46-18-203.

26 (e) The provisions of 46-18-203(7)(a)(ii) do not apply to this section.

27 (f) The probationer shall sign a copy of new or modified conditions of probation. The court may waive  
28 or modify a condition of restitution only as provided in 46-18-246.

29 (5) (a) Upon recommendation of the probation and parole officer, a judge may conditionally discharge  
30 a probationer from supervision before expiration of the probationer's sentence if:

- 1 (i) the judge determines that a conditional discharge from supervision:  
2 (A) is in the best interests of the probationer and society; and  
3 (B) will not present unreasonable risk of danger to the victim of the offense; and  
4 (ii) the offender has paid all restitution and court-ordered financial obligations in full.  
5 (b) Subsection (5)(a) does not prohibit a judge from revoking the order suspending execution or deferring  
6 imposition of sentence, as provided in 46-18-203, for a probationer who has been conditionally discharged from  
7 supervision.  
8 (c) If the department certifies to the sentencing judge that the workload of a district probation and parole  
9 office has exceeded the optimum workload for the district over the preceding 60 days, the judge may not place  
10 an offender on probation under supervision by that district office unless the judge grants a conditional discharge  
11 to a probationer being supervised by that district office. The department may recommend probationers to the  
12 judge for conditional discharge. The judge may accept or reject the recommendations of the department. The  
13 department shall determine the optimum workload for each district probation and parole office."

14  
15 **NEW SECTION. Section 21. Codification instruction.** [Sections 14 and 15] are intended to be codified  
16 as an integral part of Title 46, chapter 18, part 2, and the provisions of Title 46, chapter 18, part 2, apply to  
17 [sections 14 and 15].

19 **NEW SECTION. Section 22. Effective date.** [This act] is effective on passage and approval.
