<u>NEW SECTION.</u> Section 1. Credit for real estate investment trust contribution of real property to
 the state. (1) Except as provided in subsection (4), a real estate investment trust is allowed a credit against taxes
 otherwise due under this chapter for the fair market value of real property contributed to the state that is accepted

1 by the board of land commissioners as provided in 77-1-213 or 77-1-214.

2 (2) The amount of the credit is equal to 100% of the fair market value of the property as determined
3 under 77-1-202(3).

4 (3) If the sum of credit carryovers from the credit, if any, and the amount of credit allowed by this section 5 for the tax year exceeds the taxpayer's tax liability for the current tax year, the excess attributable to the current 6 tax year's credit is a credit carryover to the 3 succeeding tax years. The entire amount of unused credit must be 7 carried forward to the earliest of the succeeding years, and the oldest available unused credit must be used first.

8 (4) The credit allowed under this section may not be claimed if the real estate investment trust has9 claimed the contribution as a deduction under 15-31-114.

(k) principal and income in a first-time home buyer savings account established in accordance with
15-63-201 or withdrawn from an account for eligible costs, as provided in 15-63-202(7), for the first-time purchase
of a single-family residence;

(I) contributions withdrawn from a family education savings account or earnings withdrawn from a family
 education savings account for qualified higher education expenses, as defined in 15-62-103, of a designated
 beneficiary;

(m) the recovery during the tax year of any amount deducted in any prior tax year to the extent that the
 recovered amount did not reduce the taxpayer's Montana income tax in the year deducted;

(n) if the federal taxable distribution of an estate or trust is greater than the state taxable distribution of
the same estate or trust, the difference between the federal taxable distribution and the state taxable distribution
of the same estate or trust for the same tax period;

(o) deposits, not exceeding the amount set forth in 15-30-603, deposited in a Montana farm and ranch
risk management account, as provided in 15-30-601 through 15-30-605, in any tax year for which a deduction
is not provided for federal income tax purposes;



(p) income of a dependent child that is included in the taxpayer's federal adjusted gross income pursuant
 to the Internal Revenue Code. The child is required to file a Montana personal income tax return if the child and
 taxpayer meet the filing requirements in 15-30-142.

- 4 (q) principal and income deposited in a health care expense trust account, as defined in 2-18-1303, or
 5 withdrawn from the account for payment of qualified health care expenses as defined in 2-18-1303; and
- 6

(r) that part of the refundable credit provided in 33-22-2006 that reduces Montana tax below zero; and

7 (s) dividends received from a real estate investment trust to the extent they are taxed in Montana as
8 provided in 15-31-113 and 15-31-114.

9 (3) A shareholder of a DISC that is exempt from the corporation license tax under 15-31-102(1)(I) shall
10 include in the shareholder's adjusted gross income the earnings and profits of the DISC in the same manner as
11 provided by section 995 of the Internal Revenue Code, 26 U.S.C. 995, for all periods for which the DISC election
12 is effective.

(4) A taxpayer who, in determining federal adjusted gross income, has reduced the taxpayer's business deductions by an amount for wages and salaries for which a federal tax credit was elected under sections 38 and 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the wages and salaries paid regardless of the credit taken. The deduction must be made in the year that the wages and salaries were used to compute the credit. In the case of a partnership or small business corporation, the deduction must be made to determine the amount of income or loss of the partnership or small business corporation.

19 (5) Married taxpayers filing a joint federal return who are required to include part of their social security 20 benefits or part of their tier 1 railroad retirement benefits in federal adjusted gross income may split the federal 21 base used in calculation of federal taxable social security benefits or federal taxable tier 1 railroad retirement 22 benefits when they file separate Montana income tax returns. The federal base must be split equally on the 23 Montana return.

(6) A taxpayer receiving retirement disability benefits who has not attained 65 years of age by the end of the tax year and who has retired as permanently and totally disabled may exclude from adjusted gross income up to \$100 a week received as wages or payments in lieu of wages for a period during which the employee is absent from work due to the disability. If the adjusted gross income before this exclusion exceeds \$15,000, the excess reduces the exclusion by an equal amount. This limitation affects the amount of exclusion, but not the taxpayer's eligibility for the exclusion. If eligible, married individuals shall apply the exclusion separately, but the limitation for income exceeding \$15,000 is determined with respect to the spouses on their combined adjusted

gross income. For the purpose of this subsection, "permanently and totally disabled" means unable to engage
 in any substantial gainful activity by reason of any medically determined physical or mental impairment lasting
 or expected to last at least 12 months.

4 (7) Married taxpayers who file a joint federal return and who make an election on the federal return to
defer income ratably for 4 tax years because of a conversion from an IRA other than a Roth IRA to a Roth IRA,
pursuant to section 408A(d)(3) of the Internal Revenue Code, 26 U.S.C. 408A(d)(3), may file separate Montana
income tax returns to defer the full taxable conversion amount from Montana adjusted gross income for the same
time period. The deferred amount must be attributed to the taxpayer making the conversion.

9 (8)(7) An individual who contributes to one or more accounts established under the Montana family 10 education savings program may reduce adjusted gross income by the lesser of \$3,000 or the amount of the 11 contribution. In the case of married taxpayers, each spouse is entitled to a reduction, not in excess of \$3,000, for 12 the spouses' contributions to the accounts. Spouses may jointly elect to treat half of the total contributions made 13 by the spouses as being made by each spouse. The reduction in adjusted gross income under this subsection 14 applies only with respect to contributions to an account of which the account owner, as defined in 15-62-103, is 15 the taxpayer, the taxpayer's spouse, or the taxpayer's child or stepchild if the taxpayer's child or stepchild is a 16 Montana resident. The provisions of subsection (1)(e) do not apply with respect to withdrawals of contributions 17 that reduced adjusted gross income.

(9)(8) (a) A taxpayer may exclude the amount of the loan payment received pursuant to subsection
 (9)(a)(iv) (8)(a)(iv), not to exceed \$5,000, from the taxpayer's adjusted gross income if the taxpayer:

(i) is a health care professional licensed in Montana as provided in Title 37;

(ii) is serving a significant portion of a designated geographic area, special population, or facility
 population in a federally designated health professional shortage area, a medically underserved area or
