A BILL FOR AN ACT ENTITLED: "AN ACT LIMITING THE DISCLOSURE OF HEALTH CARE INFORMATION THAT IS AUTHORIZED BY SIGNING A CLAIM FOR WORKERS' COMPENSATION OR OCCUPATIONAL DISEASE BENEFITS; AND AMENDING SECTIONS 39-71-604 AND 50-16-527, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 39-71-604, MCA, is amended to read:

"39-71-604. Application for compensation --disclosure and communication without prior notice of health care information. (1) If a worker is entitled to benefits under this chapter, the worker shall file with the insurer all reasonable information needed by the insurer to determine compensability. It is the duty of the worker's attending physician to lend all necessary assistance in making application for compensation and proof of other matters that may be required by the rules of the department without charge to the worker. The filing of forms or other documentation by the attending physician does not constitute a claim for compensation.

~~(2) A signed claim for workers' compensation or occupational disease benefits authorizes disclosure to the workers' compensation insurer, as defined in 39-71-116, or to the agent of a workers' compensation insurer by the health care provider. The disclosure authorized by this subsection authorizes the physician or other health care provider to disclose or release only information relevant to the claimant's condition. Health care information relevant to the claimant's condition may include past history of the complaints of or the treatment of a condition that is similar to that presented in the claim, conditions for which benefits are subsequently claimed, other conditions related to the same body part, or conditions that may affect recovery. A release of information related to workers' compensation must be consistent with the provisions of this subsection. Authorization under this section is effective only as long as the claimant is claiming benefits. This subsection may not be construed to restrict the scope of discovery or disclosure of health care information, as allowed under the Montana Rules of Civil Procedure, by the workers' compensation court or as otherwise provided by law.~~

~~(3) A signed claim for workers' compensation or occupational disease benefits or a signed release authorizes a workers' compensation insurer, as defined in 39-71-116, or the agent of the workers' compensation insurer to communicate with a physician or other health care provider about relevant health care information, as~~

1 authorized in subsection (2), by telephone, letter, electronic communication, in person, or by other means, about
 2 a claim and to receive from the physician or health care provider the information authorized in subsection (2)
 3 without prior notice to the injured employee, to the employee's authorized representative or agent, or in the case
 4 of death, to the employee's personal representative or any person with a right or claim to compensation for the
 5 injury or death.

6 ~~(4)~~(2) If death results from an injury, the parties entitled to compensation or someone ~~in~~ on their behalf
 7 shall file a claim with the insurer. The claim must be accompanied with proof of death and proof of relationship,
 8 showing the parties entitled to compensation, certificate of the attending physician, if any, and ~~such~~ any other
 9 proof ~~as~~ that may be required by the department."

11 **Section 2.** Section 50-16-527, MCA, is amended to read:

12 **"50-16-527. Patient authorization -- retention -- effective period -- exception -- communication**
 13 **without prior notice for workers' compensation purposes.** (1) A health care provider shall retain each
 14 authorization or revocation in conjunction with any health care information from which disclosures are made.

15 (2) Except for authorizations to provide information to third-party health care payors, an authorization
 16 may not permit the release of health care information relating to health care that the patient receives more than
 17 6 months after the authorization was signed.

18 (3) Health care information disclosed under an authorization is otherwise subject to this part. An
 19 authorization becomes invalid after the expiration date contained in the authorization, which may not exceed 30
 20 months. If the authorization does not contain an expiration date, it expires 6 months after it is signed.

21 (4) Notwithstanding subsections (2) and (3), a signed claim for workers' compensation or occupational
 22 disease benefits authorizes disclosure to the workers' compensation insurer, as defined in 39-71-116, ~~or to the~~
 23 ~~agent of a workers' compensation insurer~~ by the health care provider. The disclosure authorized by this
 24 subsection authorizes the physician or other health care provider to disclose or release only information relevant
 25 to the claimant's condition. Health care information relevant to the claimant's condition may include past history
 26 of the complaints of or the treatment of a condition that is similar to that presented in the claim, conditions for
 27 which benefits are subsequently claimed, other conditions related to the same body part, or conditions that may
 28 affect recovery. A release of information related to workers' compensation must be consistent with the provisions
 29 of this subsection. Authorization under this section is effective only as long as the claimant is claiming benefits.
 30 This subsection may not be construed to restrict the scope of discovery or disclosure of health care information

1 as allowed under the Montana Rules of Civil Procedure, by the workers' compensation court, or as otherwise
2 provided by law.

3 ~~(5) A signed claim for workers' compensation or occupational disease benefits or a signed release~~
4 ~~authorizes a workers' compensation insurer, as defined in 39-71-116, or the agent of the workers' compensation~~
